- Principals: focus groups, 2-session interviewing all managed by an outside firm
- Assistant Principals: District working on building a 'bench' of people who have aspirations to grow into district roles

Contract process for Principals: first year is a one-year contract, then followed by a 3-year contract.

Fall 2026 kindergarten school year will go until 3:15pm, there will always be an option for half day. This change is mandatory in Illinois by 2027.

Bus fees: 2025 fall fee drops down to \$500 to increase ridership.
