Invitation To Bid for The Procurement of General Medical Supplies – Rebid

IB NO. 2023 – 069

1. *Tondo Medical Center (TMC)*, through the *General Appropriations Act of 2023* intends to apply the sum of *One Million Three Hundred Seventeen Thousand Two Hundred Pesos (Php1,317,200.00)* being the ABC to payments under the contract for the *Procurement of General Medical Supplies – Rebid* under *IB No. 2023 – 069*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. *TMC* now invites bids for the above Procurement Project. Delivery of the Goods is required *within the period specified under SECTION VI. Schedule of Requirements*. Bidders should have completed, within *the last three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *TMC – BAC Secretariat* and inspect the Bidding Documents at the address given below during *Monday to Friday, 8:00AM to 4:00PM*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on ***04 February 2023 onwards*** from the given address and website(s) below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount specified below*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or ***through online payment subject to transmittal of proof of payment to the BAC Secretariat***.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **27 February 2023; 10:00AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **27 February 2023; 10:00AM** at the given address below or via *Zoom with the same link stated above*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity. **TMC shall allow face to face attendance provided that the prospective bidders confirmed their attendance two (2) days prior to the activity. Maximum of two (2) participants per company shall be allowed since only twenty (20) slots shall be accommodated. Late attendees shall be prohibited to enter the venue.**

TMC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
