

Agreement between Recorded Speaker and SLAA (Sex and Love Addicts Anonymous) and ALC (Audio Library Committee of Los Angeles Intergroup)

1. Purpose - I (the Speaker) understand that my voice was or will be recorded by the Audio Library Committee (ALC) of Los Angeles SLAA Intergroup, Inc. (LA SLAA IG) for the purpose of creating a library of speaker recordings to share in service with members of SLAA. I may also have recorded my voice myself and submitted it to ALC for the same purpose. **Date of recording** _____

2. Use - I understand the recording will be available on the SLAA website (www.slaalosangeles.org) and that anyone who goes to the website may stream or download that recording. As methods of technology change, the recording may be shared with SLAA members using other means, though ALC agrees all will be in line with the traditions of SLAA and with the unanimous agreement of ALC and/or LA SLAA IG.

3. Anonymity - I choose to identify myself as _____ on this recording. ALC agrees not to identify me in any other way. To have your name 'blacked out' on the recording place 'X' here _____. ALC agrees to adhere to Tradition 12* and preserve the Speaker's anonymity. ALC recommends that you do not share information that may identify you in the recording. Feel free to provide a topic, meeting focus, title, for your recording _____

4. Lack of Profit - ALC agrees not to derive any profit from this recording nor to disseminate it in any other way beyond placing it on the SLAA website or as described in Section 2. Speaker expects no financial remuneration for making this recording.

5. Rights - Neither ALC nor the Speaker retain nor claim any rights nor ownership to the recording.

6. Responsibility - The recording will be shared in service with members of SLAA and those who visit the SLAA website, but neither ALC nor SLAA as a whole is responsible for any further actions taken by end users with the recording.

7. Recourse - Speaker absolves ALC and SLAA of all responsibility for actions taken by others after they download the recording. Speaker agrees not to pursue legal nor arbitative action of any kind regarding any matter related to this recording in any way.

8. Term - The term of this agreement is in perpetuity.

9. Entirety - This written agreement constitutes the entirety of agreement between Speaker and ALC.

10. No Partnership - This agreement does not constitute a partnership between ALC and Speaker, nor is Speaker in any way an employee or independent contractor of ALC. The speaker is simply providing a recording.

11. Severability - If any term or provision of this agreement is held to be invalid, the rest of this agreement shall nevertheless remain in full force and effect.
