## The Universal Code of Law;

---

The following are the unbreakable laws which apply to all associated parties:

- 1.) One's life is the most valuable asset, thus it is in the mutual interest of the company and the employee that their life be protected at any cost;
- 2.) Assets, shipments, information, customers, or any form of company product or service is to be protected to any extent that doesn't cause a violation of article 1;
- 3.) Understanding, accepting, and embracing the dangerous risks of the universe is a vital part of one's work, therefore employees dispel any responsibility of MAVIS for loss of life, liberty, property, or health; issues relating to these are to be solved internally by a discussion group;
  - a.) One is expected to exhaust all possibilities before aborting a started project, job, or any other form of work;
    - i.) Exemptions include if the project, job, or other form of work is aborted with consent from the head of publications;
- 4.) Discrimination, intolerance, and hate-speech are unacceptable from any individual in MAVIS, therefore it is mandated that employees must report violations;
  - a.) Employees may be given exemptions for certain assignments;
  - b.) Employees may appeal violation charges;
- 5.) While employed by MAVIS, employees shall make no mention or allusion to areas involving myth, pseudoscience, and any other statement that isn't verifiable;
- 6.) Employees accept that MAVIS shall not be held responsible for their actions;
  - a.) Employees will understand that MAVIS will do all in its power to protect its employees from injustice;
  - b.) Employees will understand that MAVIS will do all in its power to defend the actions of its employees;
  - c.) Employees will understand the relevant legal protections provided to them by the U.E.E. or any other government relevant;
- 7.) Employees will accept the tradition of employee work legally belonging to the employer;



- a.) Employees will understand that MAVIS will adhere to all standards of business and copyright law;
  - b.) Profits from your work are split 95:5. The 5 percent that MAVIS takes
- 8.) MAVIS shall recognize the important quality of on-the-spot judgement, and the decisions made on that judgement;
- 9.) MAVIS shall recognize the power for this document to be changed to meet the unpredictable future;
- a.) Changes are:
    - i.) initiated through the power of the Director and ratified by a  $\frac{3}{4}$  Senate majority,
    - ii.) created and implemented with the authority of a MAVIS founder;
- 10.) Employees are to adhere to their respective department's charter in addition to the Universal Charter;
