## **UK HASH HOUSE HARRIERS - DATA PRIVACY POLICY**

#### Introduction

The website is maintained by UK Hash House Harriers (UK HHH).

For the purposes of data protection legislation, UK HHH is the data controller.

UK H3 is the owner of <a href="www.hhh.org.uk">www.hhh.org.uk</a> and we are committed to protecting your privacy and processing your personal data in accordance with the General Data Protection Regulation (GDPR). This policy explains how the information we collect about you is used and kept securely. It also explains your privacy choices when using our website as well as your right to access your information under the Data Protection Legislation. Information we collect about you

We may collect the following information about you:

- Your name, Hash name (when used), email address, postal address and any other information you voluntarily provide to us via our website, online and via paper forms
- Information you voluntarily provide to us when you apply to become a member of UK HHH (e.g. date of birth, gender, email address, address, telephone number(s))
- Information you voluntarily provide to us when you enter an event organised by us (e.g. date of birth, gender, email address, address, telephone number(s))
- Your participation in and results of any events you take place in organised by us
- Your IP address (which is a unique identifier that computers and devices use to identify and communicate with each other) which is automatically recognised by the web server

## How we use your information

We may use your personal information for a number of purposes, including:

- Training and event entry
- To notify you about Hashing and Social Events
- To share data with club officials to administer events
- To share data with facility providers to manage access to club facilities or check delivery standards
- Membership and club management
- Processing of membership forms and payments
- Share data with committee members to provide information about club activities, membership renewals or invitation to social events
- Publishing of Hash and event results and reports on paper and online
- Website management (including the use of your IP address to monitor traffic and gather browsing behaviours of visitors to our website. We will not use your IP address to identify you in any way)
- To deal with your requests and enquiries
- To contact you for reasons related to your enquiry

# Our legal basis for processing your information

We will process your Data on the basis of the following legitimate interests:

- To enable us to carry out necessary administration relating to your membership of UK HHH and the related operation of UK HHH as a Hashing club
- To enable us to carry out necessary administration relating to, and operate, Hashes and events you enter, organised by UK HHH
- To enable us to provide relevant and necessary information via email, text or post to you about your membership of UK HHH and/or Hashes and events you enter, organised by UK HHH
- Monitor use and conduct analytics on our website

We will NOT share your data with third parties for marketing purposes.

UK HHH may also share your personal information with the police and/or other law enforcement agencies for the purposes of crime prevention or detection. If we disclose your information, we will ask the organisation to demonstrate that the data will assist in the prevention or detection of crime only when UK HHH is legally obliged to disclose it. This is done on a strictly case by case basis and through a tightly controlled process to ensure we comply with data protection legislation.

## **Protecting your information**

The data that we collect from you may be transferred between Committee Members for the purposes of Club, Event and Membership Management. We will not transfer your data outside of the European Economic Area. By submitting your personal data, you agree to this transfer, storing or processing. We will take all reasonable steps to ensure that your data is treated securely and in accordance with this privacy policy. The Internet is not generally a secure medium for communication and therefore we cannot guarantee the security of any information you send to us over the Internet.

## **Service and marketing messages**

If you are currently receiving service messages or marketing communications from UK HHH and no longer wish to do so, please let us know by contacting us via this email link or the website.

## Finding out what information UK HHH holds about you

We only record information necessary to run the club. This includes membership details, contact details and your participation in our events. Under the data protection legislation, you can ask to see any personal information that we hold about you. Such requests are called subject access requests. If you would like to make a subject access request, please contact us via this email link or via the website.

#### **Data retention**

Any personally identifiable data that we collect from you can be deleted upon written request. However, we are not able to delete the contents of emails already sent out to other mailing list subscribers.

#### Cookies

In this section you will find information on what cookies may be set when you visit the UK HHH website and how to manage and information about how to disable them.

#### What are cookies?

A cookie is a piece of text that a website transfers to your computer's hard disk in order to remember who you are. Cookies interact with your computer and our website to help improve your experience and make things easier by remembering any registration details and preferences from previous visits. Typically, a cookie will contain the name of the website from which the cookie has come, the lifetime of the cookie and a value. The use of cookies does not give us access to the rest of your computer and only the site that created the cookie can read it.

# **Automatically collected access information**

- Essential technical information: identification of the page or service you are requesting, type of browser and operating system you are using; and the date and time of access.
- Non-essential technical information: The Internet address of the website from which you linked directly to our website, and the "cookie information" described below.

By continuing to use this site you consent to the relevant cookies being set on your device.

We use the following types of cookies:

- Session cookies these are temporary cookies that remain in the internet browser's folder of your computer until you close the browser. Our website uses a session cookie which is stored in your browser until you close it to ensure connections to our servers are distributed evenly to provide optimal performance.
- Persistent/Permanent cookies these remain in the internet browser's folder of your computer for longer than the time you are visiting this website.

These cookies are used by Google specifically for Google Analytics for traffic monitoring purposes. For more information on Google's use of your information, please visit the <u>Google Privacy</u> and <u>Data Sharing</u> pages.

The cookies we use for these purposes do not track your Internet usage after leaving our website and we do not store your personal information. They will also not be used in connection with any other information to identify you in any way.

UK HHH will not use cookies to collect personally identifiable information about you. You can restrict or block the cookies which are set by our websites by accessing your Internet browser settings.
