Welcome Suzanne Burwell: Melissa introduced Suzanne Burwell, who brings with her tremendous amount of experience. She works in partnership with a number of schools.

February Outdoor Improvement Project presentation:

Suzanne then gave a presentation on ideas and the process of landscaping the school for the benefit of the learners. Suzanne mentioned after her presentation that this project will have to be run through the board, since the board owns the property. The board, school and council should have a meeting to discuss the scope of work and what is important to each of the parties. Suzanne proposed that council approve at least \$ 10,000 to appoint landscaping architects to work with the school on the outdoor project.

Motion to move forward right now to approve up to \$12,000.00 to spend for a landscape architectural plan for the improvement of the back outdoor space improvement plans, and the circular space.

Dee seconded the motion. Motion passed.

Dee proposed that the council advise the families of the school about the approved expense due to it being such a large amount.
