Truxton Town Board Meeting Minutes Wednesday May 21, 2025 7:00 p.m.

CALL THE MEETING TO ORDER WITH THE PLEDGE OF ALLEGIANCE.

Truxton Town Board Regular Monthly Meeting was called to order at the Town Municipal Office Building by Lloyd Sutton, Jr, on May 21st, 2025, at 7:00pm.

APPROVAL OF THE MINUTES

Motion to approve April meeting minutes with modifications was made by Molly McDermott. The second motion was made by Ryan Murray. All in favor.

PRIVILEGE OF THE FLOOR:

TLC was in attendance to provide updates. They have purchased Smith Ambulance- pending CON (certificate of need) with approval from the regional council for the 3 regions that will be covered. The current CON with Cortland County under TLC covers mutual aid in Truxton. Looking at the possibility of expanding the garage at Bonsbak property to store ambulance and paramedic staff- the cost of this expansion will impact the contract with Town of Truxton. Contracting with TLC will be significantly higher than the current contract with Smith Ambulance, however, if contracted, the residents' ambulatory bill is reduced. The delay in response times is due to long hold times at hospitals waiting for available beds or transferring to another facility. New legislation to allow ambulances to drop off at urgent care versus the emergency room for non-critical needs. TLC will be able to offer mutual aid to Madison County.

Joe Pullman attended the Cortland County Planning Board meeting regarding solar opportunities in remote areas. Concern regarding need for battery storage and the impact that it will have on the surrounding area and fire departments. Joe is pushing for other towns to be on email list to raise awareness for solar projects along with wind projects.
