## RESOLUTION

WHEREAS, Iowa Code Ch. 279.8 authorizes local school boards to govern their respective districts, including adopting policies for their own governance; and

WHEREAS the Board may, by formal action suspend or rescind board policy as deemed necessary, appropriate or in the best interests of the District.

NOW, THEREFORE BE IT RESOLVED, that the North Tama County Community School Board hereby suspends provisions of its board policies and/or whole policies, as identified by the District Superintendent or designee, if such suspension is necessary to implement written guidance from state or federal agencies relating to containing COVID-19 for the duration identified by the Governor of the State of Iowa, or as otherwise determined by the Board.

BE IT FURTHER RESOLVED that the District Superintendent will consult with and report to the Board as feasible and appropriate regarding the closure of any school or facility and efforts to implement written guidance from health and government agencies.

BE IT RESOLVED Superintendent is authorized to close any school facility without further action by the Board of Directors. Such closure shall continue until such time as the Superintendent, in consultation with appropriate health and government authorities, deems it in the best interests of the District and its students to open schools.

BE IT FURTHER RESOLVED that the Superintendent is hereby authorized, based upon the needs of the District and guidance from health and government agencies, to direct staff assignments during District closures, including but not limited to essential employees who must report to work, employees who may be reassigned, and employees whose services are not needed.

BE IT FURTHER RESOLVED that during a temporary full or partial closure of the North Tama County Community Schools due to the COVID-19 Pandemic, the Superintendent is hereby authorized to pay customary and regular compensation to employees that are temporarily out of work.

This resolution is intended to replace a previous resolution approved by the Board on March 20, 2020 (which was effective retroactively starting on Tuesday, March 17) and re-approved by the Board on April 6, 2020 and May 18, 2020. This resolution will be placed on the agenda of each monthly board meeting and will remain in effect until it is rescinded or amended.
