Introduction

Project Rebirth has been authorised by and overseen by Assistant Owen Marston of the Site-65 Administrative Sector. Site-65's Director of Research Jacqueline Claire-Tierson has been selected as the project head due to her expertise in the field of Necromantic based Thaumaturgy.

Overseer Assistant Steven Connor, Subject Alpha, was terminated in the crossfire of a conflict between Alpha-1 and Omega-1 operatives during a firefight on the Core Sector bridge in Site-65. The corpse was retrieved by MTF Alpha-1 Command Sergeant 'Verlocity' and stored in a secured cooling chamber under the jurisdiction of the Director of Research.

Project Objective

The Director of Research has requested that we compile what she described as "a giant oven". The plan she has outlined includes encasing Mr Connor's corpse in a 'cocoon' of clay and placing the body into the chamber of the custom oven. Upon lighting the flame of the oven, the Director will imbue the flames with a bundle of Witches Elm to help channel the Thaumaturgical essences through Mr Connor's Clay Cocoon.

Once the ritual is under way and the appropriate preparations are complete, the Director will utilise her Thaumaturgic abilities to imbue Mr Connor's body with a new life force typically associated with the capabilities of Type-Blue entities.

Upon the process being complete, the Director is certain that Mr Connor will be 'alive' once again and able to conduct his duties to an appropriate standard.

Outcome

Evaluation conducted by Doctor Stanley Milton

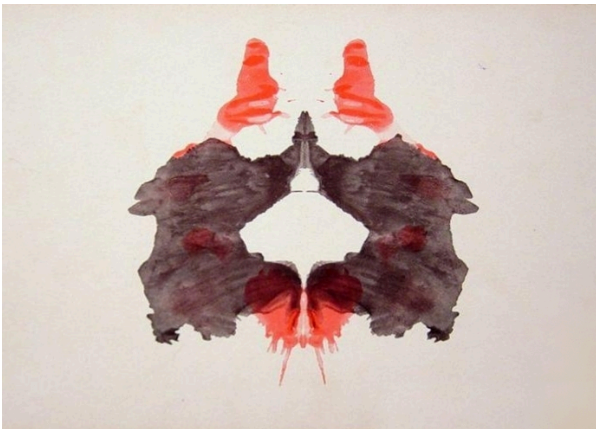
Physical Examination:

Mental Examination:

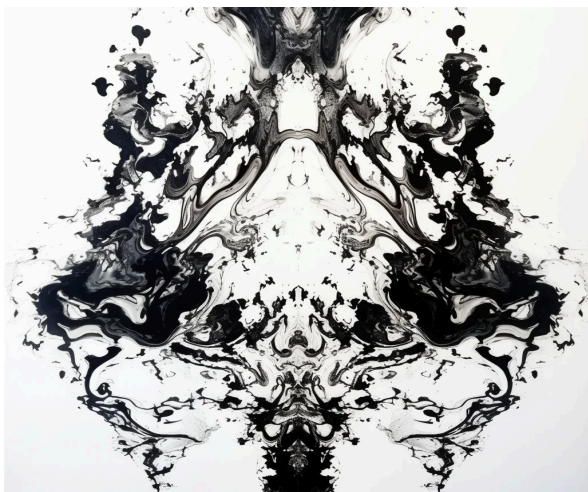
Response - "2 (two) demons dancing around an open flame."
