On 21 November 2017, the Hon Bill Marmion, MLA, presented a petition to the Legislative Assembly calling for the immediate cessation of the redevelopment program at Karrakatta Cemetery. If you believe the public supports this practise, you can have no reason to suppress this issue, to hide from the public the reality of what has been done at Karrakatta since 1977 or to gloss over the devastation it has already wrought on our heritage and on WA families.
