■ Container Deposit Law - LSR 24-2793 - Rep. Sherry Dutzy

- Current language more palatable to industry
 - No handling fee; program run by PRO (producer responsibility organization)
 - Appeals to redemption centers (retail) are compensated for dedicated space
 - Performance targets, minimum redemption rates; industry run
 - Underscore the reuse/refill component, including infrastructure
 - Funds from unclaimed deposits used to uplift infrastructure
 - Concerns about timing of draft coming out and sign off process 11.17 to return drafts to sponsors

■ PFAS - LSR 24-2805 - Rep. Karen Ebel

- Bans PFAS upstream landfill leachate
 - Products: carpets, rugs, cosmetics, fabric, fem hygiene, food packaging, juvenile products, PPE, dental floss, upholstered furniture
 - Establishes intrajurisdictional clearing house of state agencies to implement technical requirements; streamlines database, enforcement, education components
 - Karen's strategic experience with DES enhances bill's component
 - o By 2026 all mfrs must notify of PFAS in products; requires labeling
 - MN & ME require notification to a shared database
 - o Shared database will make it easier for subsequent state to engage
- Unregulated, not understood because it's not disclosed, studied
- Focus on post pollution impacts not enough
- NE Waste Management Officials Association northeast WM professionals have drafted a bill to ban PFAS; phases our non-essentia PFAS use

■ Skip the Stuff - LSR 2270 - Rep. Tony Kaplan

Requiring restaurants to provide single use plastic utensils only on request
