V) Treasurer's Report

- a) Bernie Grimme reviewed the financial holdings for the RehabACTion from 1/1/2022 through 9/28/22
 - i) Deposits: \$20,189.20
 - ii) Costs including total payments for appreciation funding: \$8,778.57
 - iii) Profit/Loss: \$11,410.63
 - iv) Checking account balance of \$84,095.07
 - v) \$9,278.24 belongs to other agencies- RehabACTion acts as the fiscal agent
 - vi) RehabACTion Assets were \$74,816.83
 - vii) \$2,000- set aside for provider training- due to most trainings being held virtually- this amount was not spent

VI) Vocational Rehabilitation Updates – Eric Weiss and Gaye Mattke

- a) Eric Weiss
 - (i) Encouraged members to be a part of the RehabACTion board
 - (ii) DRS committed to providing more training to providers
 - 1. Some of the trainings focus will be on competitive integrated employment, customized employment, etc. and Griffin-Hammis is providing the training
 - 2. In future, will be new training opportunities including some about supervision and leadership
 - 3. Mentioned if providers have their CESP then there is a 25% increase in rate
 - 4. Customized Employment rates for initial discovery phase increased 6% and recently an additional 10%

- (iii) Transition services were discussed and how students with disabilities make up about 60% of the active caseloads which has exceeded expectations
- (iv) Summer camps for pre-ets events will be available again this summer so agencies can apply to receive that funding

b) Gaye Mattke-

- (i) Financial need is no longer needed for assistive technology devices through the SBVI VR program
- (ii) Starting Oct. 1, the SBVI IL program revised the financial need criteria, and it no longer takes into account the investments of the individuals and strictly looks at annual income
- (iii) SBVI as an agency is looking for drivers to drive clients and boards members PRN
- (iv) In the near future, there should be a new and improved website, along with a video to highlight services provided at the SD Rehabilitation Center for the Blind
- (v) The SD Rehabilitation Center for the Blind is planning to get a remodel at the beginning of 2023.
