- 4) Photographic ID still valid

- 6) Certificate of voter registration within 12 months
- 7) Correspondence between you and a government authority regarding the receipt of benefits (pension, unemployment benefits, housing benefits, etc.) within 6 months

1) Utility company bills

Bills for mobile services such a mobile phone etc. are not accepted as proof of place of residence.

2) Bank statement

Your bank balance and transaction details may be blacked out. However, please ensure that the following information is clearly legible:

Tax assessment

Uploaded tax assessments must be from the tax, financial or government authority responsible for your current home address for the verification process to be completed successfully.

4) Photographic ID

Photographic ID on which your home address is visible.

5) Mortgage statement

6) Correspondence from a government authority regarding the receipt of benefits

- It must include your first name, surname and current home address.

7) Certificate of voter registration

- Must have been issued by the government authority responsible for voter registration in the area in which you live.
- It must include your first name, surname and current home address.
