The Oklahoma Council for Online Learning Excellence (COLE) invites you to share your ground-breaking ideas, research and best practices in Open Educational Resources (OER).

Submit a conference presentation proposal for the **virtual event** to be held **Friday, December 3, 2021** (between 10:00 A.M. and 3:00 PM CST).

All presenters must [register for the event](#). This event is FREE!

We invite proposals with a focus on the following areas, all with an emphasis on inviting *voices from the field*:

1. **The Value of Open:** (includes introduction to OER, benefits, open licensing, shared examples of OER, and discussion of OER adoption models) *Beginner*
2. **Teaching and Learning with Open Educational Resources:** (includes ways to find and use free, CC licensed and public domain content, and incorporating open pedagogy, improving student learning outcomes using OER) *Beginner/Intermediate*
3. **Implementing and Scaling OER Initiatives:** (includes collaboration, starting your initiative, student engagement, policy, strategies, structure and process, institutionalizing and communicating about OER, COVID-19 and OER - its impact on the future) *Intermediate/Advanced*
4. **Inclusive Practices with OER:** (culturally-responsive and equity-focused pedagogies and OER, publishing and printing, accessibility of OER content, data on the impact of OER, research on OER) *All Levels*

Proposal Criteria and Submission Process

Reviewers use the following criteria when evaluating submissions:

- **Relevance** – The topic is relevant to Open Education and contributes to research and/or effective practices in the field.
- **Coverage** – The topic is clearly described and the session covers the topic adequately.
- **Innovation** – The topic has innovative concepts.
- **Research/Outcome Based** – The topic is research/outcomes based.
- **Takeaways** – The session includes key takeaways for participants.
- **Improved Processes and Best Practices** – The session could help improve processes and/or best practices in the field.
- **Knowledge** – The speaker or speakers appear to have sufficient knowledge and expertise to address the topic.
