Guidance Document: Data Protection Policy

What date is collected?

To participate in qualifications, training courses, swimming sessions or events through Beyond the Water, you are required to complete forms fully which may include personal and identifiable details including:

- Name
- Address
- Age
- Date of Birth
- Emails, telephone numbers etc
- Relevant medical information
- Emergency contact information including name(s), address, and telephone number(s)

How are your details used?

- In the case of a medical emergency, your details may be shared with emergency services, along with your next of kin details
- Medical details and medication are an essential part of any handover to the emergency services should the need arise
- Beyond the Water will never use your data to contact you for marketing or events unless permission is given by you
- Beyond the Water may contact you directly if changes to a qualification, course, swim session or event occur that you are booked on to, which require your personal attention
- Beyond the Water uses the information provided by you to register you with the relevant Awarding Body when you are attending training courses or qualifications

It is your responsibility to inform Beyond the Water if any of your details change before your next qualification, training course or swim session / event.

Beyond the Water will not be held responsible for any incorrect information held that has not been updated in accordance with this policy.

How are your details stored?

- Beyond the Water will never sell, give, or allow your data to be accessed by any other company without your consent
- Your details will be stored in compliance with Data Protection Regulations
- Only specific individuals within Beyond the Water will have access to this information
- At least one of these individuals will be present at any given event or session

Your details will be stored for a maximum of 2 years after your last course or session with us and then destroyed. After this time, you will be required to complete a new declaration form to continue participating in sessions or events Beyond the Water.

For qualifications and training courses: Your details will be stored for the period required by the awarding body and regulator and then destroyed.
