**Onekama Consolidated Schools  
Walking Track / Fitness Center Policy**

1. In an effort to enable everyone to enjoy the walking track and fitness facility, please read through and abide by the following guidelines:
2. No drugs, tobacco or alcoholic beverages are permitted on any school district property.
3. Gum, candy, food or drinks are not permitted in the walking track / fitness facility areas (exception will be closed container bottled water).
4. All participants must complete a Fitness Center Orientation to ensure proper understanding and use of fitness equipment prior to the issuance of a fitness center swipe key.
5. Street shoes will not be permitted on the walking track or fitness equipment. Clean / appropriate exercise shoes must be worn at all times.
6. Middle and high school students only will be permitted in the fitness facility after school hours / outside of sports practices through purchased membership. Middle school students will be allowed membership use under direct parental supervision and high school students will be allowed membership without direct parental supervision.
7. An identifying swipe key will be issued upon registration. Entrance and exit times from the facility will be monitored by the swipe key as well as security cameras. Swipe keys are not to be shared. Member shall be held solely responsible for immediately reporting to the district a lost or stolen card. Member shall incur a replacement cost for lost or stolen card. Photo identification could be requested periodically to verify membership.
8. Use during summer vacation, holidays, or during other vacation periods shall not conflict with building cleaning and renovating programs and will depend on the availability of building service personnel for supervision.
9. Responsibility for complying with the rules and regulations concerning use of District facilities rests with the authorized individual user, and any infractions of the above regulations may be grounds for refusing to grant subsequent use of District facilities.
