Dear Deans Treanor, Bellamy, and Bailin:

We, the Muslim Law Students Association, write on behalf of Georgetown's Muslim students, underrepresented students, and the signees of this petition. We are calling your attention to Professor Susan Deller Ross's Islamophobic and racist behavior that has compromised the International Women's Human Rights Clinic (IWHRC) and the International and Comparative Law on Women's Human Rights course. We are extremely disappointed in the Law Center's handling of these reported incidents, especially in light of the recent increase in racist student-faculty experiences at GULC. Student testimonies and Professor Ross's past exams and public interviews show an alarming pattern of using dangerous rhetoric towards Muslim students, their religious beliefs, and diverse communities across the globe.

# Specifically, Professor Ross:

- Writes and administers violently Islamophobic and racist exams. Naming all of the offenses of Professor Ross's exams would be too overwhelming for this statement, and we urge you to read through more material in a 17-page memo here.
  - o A 1999 exam asked students to advocate on behalf of France's hijab ban in schools.
  - o In 2004, another exam similarly asked students to uphold a hijab ban, showcasing how Professor Ross's pedagogy equips students with legal arguments to unveil Muslim women and girls and strip them of their fundamental freedoms. This bigotry is seen in some model student exams that describe the hijab as a device that inherently subordinates women to men and impedes their physical movement.
  - On a recent 2020 exam, Professor Ross asked students to advocate for the Hindutva Bharatiya Janata Party (BJP), an extremist right-wing organization responsible for egregious human rights violations, including the mass murder and lynching of Muslims in India and Indian-occupied Kashmir. This exam is especially outrageous to GULC students who have had family members murdered by the BJP. The exam does not give students the opportunity to argue against this position, but only allows students to argue along Professor Ross's biases, giving high scores to exams that argue Islamic practices are equivalent to human rights violations.
- Based on <u>student testimonials</u>, Professor Ross creates a discriminatory classroom environment that hinders students' learning outcomes. Students noted Islamophobic themes in course material and class discussion, describing course materials as pushing a specific narrative, lacking nuance, and promoting negative stereotypes. Students described tokenizing and discriminatory classroom practices such as having minority students act out scenarios of human rights abuses stereotypical to what Professor Ross perceived to be their cultural backgrounds. Students also described feeling discriminated against because of how they spoke or their ethnic or religious backgrounds.
  - "Prof. Ross subjected me to unequal treatment and unacceptable discrimination due to her biases and general prejudices against my racial identity and faith. I have endured emotional distress, sleepless nights, helplessness, gaslighting by Prof. Ross, [and] hours

discussing my issue with various GULC administrators with...the burden of figuring out a way to file a complaint against an 'irreproachable' tenured clinic professor at GULC.''

• Finally, but certainly not least, Professor Ross uses Georgetown resources to contribute to public Islamophobic discourse through <u>publications and interviews</u> that characterize Islam as devoid of human rights and contributing to the oppression of Muslim women - a pedagogical failure to analyzing such concepts accurately. In a publicly circulated Kenya report she stated, "Muslim women are given different and lesser rights than similarly situated Christian women, precisely because of their husband's identity as Muslim." In a 2003 interview, she stated that "for a [IWHRC] Tanzanian project ...we [] attack[ed] the Islamic system which gives women a tiny portion [of rights]."

We find these actions highly offensive, especially for a clinic intended to elevate and liberate women yet instead perpetuates racist stereotypes and robs Muslim, African and other women of color of their agency. Contrary to Professor Ross's beliefs, we, the Muslim women at GULC, believe our faith and hijab is a source of strength and empowerment that is not connected to any form of 'subordination' - we wear it like armor. Professor Ross's negative stereotypes and orientalist conceptions of Islam, Muslims, and African countries within the human rights framework perpetuates a dangerous trope of white saviorism that feeds into a culture of hate crimes against Muslims and historically harmful policies like the #MuslimBan. Professor Ross's teachings are nothing short of a wink and nod to Islamophobic tropes that compromise our ability to obtain an equal legal education at Georgetown.

In order to proactively address the decades-long trend of racist behavior while simultaneously amplifying <u>BLSA</u>'s and <u>APALSA</u>'s recent demands, we ask that GULC take the following steps:

- Remove Professor Susan Deller Ross from evaluating students in a non-blind grading system.
- Revise the IWHRC and International and Comparative Law on Women's Human Rights course curricula with MLSA having an active role in the process of getting (a) Muslim expert(s) to review the curriculum.
- Mandate anti-Islamophobia and anti-discrimination specific training for all GULC faculty.
- Reserve a seat for a MLSA representative on the Faculty Appointments Committee.
- Institute a <u>clear</u> and <u>direct</u> internal system of filing and investigating a complaint to allow students to anonymously bring concerns to administration and receive quick, meaningful action.
- Administratively investigate an audit of grades Professor Ross administered in the past 2 years.
- Integrate better teachings of legal issues involving Islam in GULC beyond this clinic.
- Provide alternative clinic and course opportunities for students who have had to forego this clinic and course because of Professor Ross's Islamophobia and bigotry.

At best, silence is neutrality. Without these necessary steps, however, it is violence. It is to say to Muslim law students: we see you, we hear you, and we will even build a prayer room for you, but we will not stand with you while the crux of your identity is under attack.
