

Liberty Local School District HUDL - Informed Consent and Release Form

I, the undersigned parent/legal guardian, hereby understand that the Liberty Local Schools Board of Education (“District”) is utilizing the online services of **HUDL**, a software and service company focused on providing tools for sports teams and athletes to improve performance through video analysis, data analysis, and communication. I also understand that as part of this activity, my child may be required to submit his/her name, email address to access and use this online application.

I understand that to the extent that either I or my child are provided with or create a password for the use of this site, my child and I can help protect against unauthorized access to my child’s account and personal information by appropriately protecting and limiting access to this password and appropriately logging off the account when finished. I hereby acknowledge and agree that the District does not own or control **HUDL** and any of my child’s works (name, image, likeness, spoken words, student work, performance, or other personally identifiable information, in any form, hereinafter collectively referred to as “Works”) that are posted on or through this website shall be managed and controlled by **HUDL** in accordance with its privacy policy and terms of service. I further acknowledge that my child and I have read **HUDL**’s [Terms of Service](#) and [Privacy Policy](#), true copies of which are linked to this informed consent and release.

I DO authorize my child to participate, use, and submit Works for posting on **HUDL**. I also expressly authorize the District to use, in whole or in part, my child’s Works in connection with **HUDL**, including, without limitation, the posting of these Works on or through **HUDL**.

I DO NOT authorize my child to participate, use, and submit Works for posting on **HUDL**. However, in allowing my child to participate in District sponsored or related extracurricular activities and/or interscholastic athletics, I understand and agree that the District, as well as other schools, will continue to utilize **HUDL**. As such, I understand that my child’s Works may still appear on **HUDL** through content uploaded by the District and/or other schools uploaded to **HUDL** (i.e., practice footage, and/or game footage involving multiple teams). I also acknowledge that the District does not control content uploaded by other schools and is not responsible for how those schools manage or otherwise share content.

I understand that neither the Liberty Local Schools Board of Education, nor their respective officers, directors, agents and/or employees shall compensate either me or my child in connection with the posting of the Works on or through **HUDL**. By signing this informed consent and release, I also am releasing the Liberty Local Schools Board of Education and their respective officers, directors, agents and/or employees from and against any and all liability, loss, damage, costs, claims and/or causes of action arising out of or related to my child’s Works being posted on or through **HUDL** and/or for my child participating and using **HUDL**.
