The Oregon Music Education Association is the state affiliate of the National Association for Music Education (NAfME). We are a non-profit organization whose mission is to promote excellence in music education and serve the professional needs of its members. All-State has been an annual event in Oregon for more than 60 years. Providing thousands of students an opportunity to gain confidence with their instrument, meet other musicians their age from around the state, and make lifelong memories.

What is All-State?

All-State is an honor music ensemble program run by OMEA. This is an extremely rewarding experience for students to gather with fellow motivated student musicians from around Oregon and have the privilege to rehearse and perform with renowned guest conductors.

In order to apply for a spot, each ensemble, excluding our All-State Elementary Choir, requires an audition. All OMEA members must submit an application on behalf of their students through OpusEvent.com along with their audition. If selected, families and the students' teacher will be notified via email, and families or schools can complete the registration and payment process online by the November deadline.

After the registration process is complete, folders with sheet music and more information regarding the hotel, rehearsals, and the performance are shared with the students' music teacher before winter break. Students are expected to learn their music on their own in advance of the event. Families are invited to come watch them perform. Students are required to stay in a hotel in Eugene and share a room with three other All-State students of their age level.

When and where is All-State held?

OMEA All-State is held over Martin Luther King Jr. Weekend in Eugene, Oregon. Rehearsal and performance locations vary depending on the year and which ensembles students participate in.

Parents/Guardians must supply or arrange transportation to and from Eugene. Some schools might provide transportation to the event. Please note this is not an OSAA or school-sanctioned event. Our event is not rescheduled if there is inclement weather, and no refunds are given.

Does it cost money to participate in All-State?

Yes, All-State does cost money.

There is a fee to submit the All-State application and audition in September. This covers the cost of running the event website to manage auditions and applications.

If a student is selected for an ensemble after auditions have been screened in October, there is a separate event registration and participation fee. This fee covers the cost of running the event: hotel rooms, meals, transportation, rehearsal space rental, performance space rental, equipment rental, travel and hotel for the guest conductor, etc.

The All-State fees varies depending on grade level:

Do All-State Concerts cost money for families?

Yes, concert ticket sales are factored into the budget of running the event weekend. Tickets are sold online at SeatYourself.com. OMEA members with students in All-State must also register for the state conference, which coincides with the All-State event. Included in teachers' conference registration are concert tickets.

Parents and guardians must purchase tickets for each concert online through SeatYourself.com. Ticket prices are:

AUDITION and PLACEMENT INFORMATION

How to Audition for All-State

Your student must work with their music teacher to complete the required recordings (separate files for each required excerpt). The cost to submit an audition for high school students is \$22, middle school students are \$17, and \$7 for elementary nominations (no audition required for elementary).

- Students and parents/guardians fill out and sign the All-State application at the end of this document and turn it in to their teacher.
- Teachers must be OMEA members and complete the application and audition process online through OpusEvent.com.
- The application and audition fee must be paid via credit card by the teacher/school through OpusEvent.com by the audition deadline.
 - *The fee must be paid first before audition files can be uploaded.*

Teachers must be current members of NAFME/OMEA to submit applications and/or nominations and auditions through OpusEvent.com, along with also attending the conference.

Audition Recording Instructions

Record the student performing by themselves without a metronome. Please see exceptions for High School Jazz Band and Choir recordings in the audition material. Do not speak the name of the student, teacher or school. The student must perform each exercise with the correct pitch, rhythms, quality tone, articulations, steady tempo (see tempo markings on each exercise). Each audition track should be a separate audio file (mp3, wav, aac, ac3, aif, amr, au, caf, flac, m4a, m4b, oga, ogg, sf2, sfark, voc, weba, wam). Teachers and students may not electronically or otherwise enhance any recordings. By submitting the audition materials online via OpusEvent.com, the director attests that these conditions were met and agrees to adhere to all deadlines set by OMEA and understands that all deadlines are final.

Audition Screening and Placement Process

Audition screening is “blind.” Judges do not know the students’ name or school information. Screeners will listen to each track and assign a score from 1 – 100. After all the auditions are scored, each student will have an overall score and then they are ranked and placed. Screeners will consider the following: Note/pitch accuracy, Rhythmic accuracy, Tone quality, Articulation, Dynamics, Style, and Phrasing

When do we find out which students are selected?

Teachers and families are notified of the results on October 21st via the email addresses entered into OpusEvent.com. Teachers, be sure to carefully type in parent/guardian emails, if

there is anything incorrect about the email address, it will not be sent. Examples: extra space in front of or at the end of an email address, missing periods, etc.

What is the difference between Symphonic Band and Wind Ensemble?

Symphonic Band is open to students in schools with an OSAA school classification of 1A – 4A. Students from 5A and 6A high schools **may not** audition with the Symphonic Band materials, they **must** use the Wind Ensemble audition material or they will be disqualified.

Wind Ensemble is for students from 5A and 6A schools* (see below). These students **must** submit an audition using the Wind Ensemble material.

- *If a small school student (1A - 4A) wishes to audition for the Wind Ensemble/Symphony Orchestra, they are welcome to do so, and must audition with the **Wind Ensemble** audition materials.
- However, students from small schools can only submit one band audition.
- All students that submit using the Wind Ensemble material that are not selected for the Orchestra or Wind Ensemble will be considered for positions in the Symphonic band.

One of OMEA's goals is to increase the opportunities for students from smaller schools to participate in All-State. 5A-6A students will be selected to fill out the Symphonic Band **after** all of the small school students who meet the minimum audition scores are accepted into the Symphonic Band first.

When completing applications in Opus, be sure to mark your school's OSAA classification, we must collect the OSAA school classification for each applicant. While it is not directly applicable to most ensembles, it is needed to correctly populate the Symphonic Band. It also provides important statistical data for tracking levels of participation from across the state. This can help us further tailor our services to the needs and realities of our schools and students.

How are High School Band students placed?

The approximate size of the Wind Ensemble is 100 players and the Symphonic Band is up to 150, depending upon the pool of applicants and the needs of the literature. Students that apply for Wind Ensemble/Symphony Orchestra but are not selected may be placed in Symphonic Band as long as all 1A-4A representation requirements are met. The exact formula for this integration varies from year to year or from section to section based on the auditioning pool. The goal of the Symphonic Band is to include as many qualified small schools students as possible in the All-State experience; every effort is made to incorporate these students into every part, in every section.

Wind Ensemble auditionees will be up for consideration for both Wind Ensemble and the Symphony Orchestra. Acceptance and placement into an ensemble will be purely based on rankings from the screening process and on the placement formula outlined below.

- The Orchestral wind seats are filled with the 1st, 3rd, 5th, and 7th ranked players from the screening process, and ranks 2, 4, 6, 8 in the Wind Ensemble.
- Once the Orchestra seats are filled, all remaining Wind Ensemble seats are filled in rank order from the screening process.
- The percussion seats in the Orchestra will first be filled with the #1 Timpanist and #1 Snare. Remaining percussion seats will depend on the literature and will be filled in rank order.
- The number of wind seats in the orchestra sections will be determined by the needs of the literature.

OpusEvent.com Troubleshooting

I don't see a "Submit" button - How do I know my students' application/audition is submitted and complete?

- Once all student information has been entered and their recording files uploaded, you will see "Complete" in green next to their name. (if your browser window is small/not full screen, you may need to enlarge your window to see the "Complete" on the far right of the screen)

I just renewed my NAFME/OMEA membership, how soon will it connect with OpusEvent?

- Opus and NAFME can "speak" in real time - but - you need to tell Opus to "talk" with the NAFME site to refresh your membership renewal in OpusEvent.
- Go to your account profile in Opus (top right corner of the site) Scroll down to the "Membership Information" portion of your account profile and click on the Edit Pencil to update your membership expiration date.

When I log into OpusEvent.com, I don't see the Oregon All-State event option.

- Go to your account profile in Opus (top right corner of the site) and check that your NAFME membership is current. (Opus does not automatically update your NAFME renewal - you must do this yearly/manually)
- Scroll down to the "Membership Information" portion of your account profile and click on the "Edit Pencil" to update your membership expiration date.

All State Policies & Procedures

SECTION (12) A. TEACHER MEMBERSHIP AND CONFERENCE REGISTRATION REQUIRED (5/22/04)

Teachers of students of all ages in OMEA honor groups shall be required to register for the full conference, pay in full, and be current NAFME/OMEA members. If found to be in violation, that school's specific discipline (i.e. band, orchestra, choir) will be sanctioned from participating in honor groups until the bill is paid in full. In extenuating circumstances where a registered teacher is unable to attend, they may designate a fully registered proxy OMEA member teacher who is able to support students in case of emergency or disciplinary action.

We, the undersigned, acknowledge the following OMEA policies and procedures:

12.C ALL-STATE STUDENTS

1. To be eligible for an All-State honor group, the music student shall be enrolled in the class for the appropriate performing ensemble for the instrument/voice on which they are performing.
 - a. If there is no corresponding music ensemble available at the school for the student's instrument, the student may participate through an OMEA member teacher at their school, at the OMEA member teacher's discretion.
 - b. If there IS a corresponding music ensemble available at the school and the student does not participate in the school program, the student may not participate.
2. We welcome home school students as long as they are regularly participating in a school music class, offered for credit, and taught by a current OMEA member.
3. If there is an appropriate performing ensemble available at the school and the student does not participate in the school program, the student may not participate in All-State.
4. The OMEA member teacher submitting the student audition must attend the conference and accept all the responsibilities of a teacher with an All-State student, if the student is selected.
5. If there are no music classes offered in the school the student attends, students may be recommended by an OMEA member who teaches/taught the student. The OMEA member must attend the conference and accept all the responsibilities of a teacher with an All-State student.
6. If there is a corresponding ensemble offered at the school, students must be regularly participating in a school music program from the time of application through the time of the event.
7. It is recommended that students meet OSAA's academic requirements and personal conduct rules to participate in All-State. We advise checking the OSAA website to see if there are changes to the following guidelines.
8. Students are required to stay in the hotel that their performing group is assigned with other All-State students. Students with extenuating circumstances may stay in the All-State hotel with their parents upon the approval of the Executive Board. The decision of the Executive Board is final. Emails concerning special needs requests must be sent no later than 2 months prior to the event. Email requests to the Executive Director.
9. All-State participants must be registered (with all forms completed and signed by all appropriate parties) and paid prior to the posted deadline.
10. Students will not be admitted unless forms are complete and payment made.
11. Unless otherwise stated, All-State participants shall wear performance attire appropriate to their individual school music program policies.
12. No refunds shall be made except for medical or family emergencies within 10 days of the event. A letter from a physician for medical excuses, or parent/guardian for family emergencies, must accompany the request for refund. Each case will be determined on a case-by-case basis by the Executive Board. In either case, 50% of the fee will be retained.

12.D AUDITIONS

1. Teachers and students may not electronically or otherwise enhance any recordings. By submitting the audition materials online, the director attests that these conditions were met. (5/30/2015)
2. If the screening committee agrees that a recording has likely been electronically altered or enhanced, that recording will be disqualified. The decision of the screening committee will be final.
3. By submitting the audition materials online, the director agrees to adhere to all deadlines set by OMEA and understands that all deadlines are final.
4. Audition screening fees are non-refundable.
