

Seth Rich was discovered by the DNC after the Bernie/DNC voter data compromise controversy & it was his boss

Cont'd- that AMY DACEY might be a person at DNC connected to Seth since she was his boss while he was working on the VOTER APP project, I searched back through the WIKILEAKS PODESTA files to see if she came up and YES SHE DID.

I will start from here and connect it all back to Seth and how she might be a key player in all of this.

Rewind back to 2007, AMY DACEY worked SEUI and has a LONG history of working with PODESTA. Here's an email about a meeting she set up with PODESTA with lots of names we will recognize (hint: Ballsack Eyes).

She then went on to be the CEO of the DNC and was leading the investigation into the voter database compromise that happened on 12/15/16: The DNC voter database was compromised and the Bernie campaign ended up with voter info from Hillary's campaign. They had NGA VAN do a few audits to find what was compromised and reported the results as to who was responsible in the Bernie campaign for accessing info they weren't supposed to. The director of voter data for the Bernie campaign was fired as a result. This is the report she sent out after the initial audit:

At the end of this report, she refers to continuing the audit which is when I believe they have initially discovered SETH RICH as a leaker. The DNC is currently beginning the process for securing an additional, independent audit by data security firm of NGP VAN's procedures. As a result of this analysis, NGP VAN found that campaign staff on the Bernie campaign, including the campaign's NATIONAL DATA DIRECTOR, had accessed proprietary information about which voters were being targeted by the CLINTON CAMPAIGN—and in doing so violated their agreements with the DNC.

She (AMY DACEY) moved to the government relations department with SEIU:

Other important note: he was working on the voter app project for DNC when he discovered fraudulent voting sites issue, which was reportedly one of his motivations to work with Wikileaks. If you read the email exchanges during the Bernie/DNC Voter compromise, the Hillary campaign wanted to know the "ACTUAL DAMAGE" of the compromise perhaps afraid the fraud would be

Let's set up a timeline

2008 – IWILLVOTE website created.

2009 – Ian Reynolds becomes Senior Systems Administrator to DNC.

2010 – Ian Reynolds is no longer Seniors Systems Administrator (he goes to Peace Corps from March 2011 to May 2013).

June–November 2010 – Seth Rich is campaign staffer for the Nebraska Democratic Party.

2011 – Seth Rich graduates from a Jesuit college.

March 2012 – Seth joins Greenberg Quinlan Rosner as Research Data Associate.

2013 to present year (2017) – Ian Reynolds is working as “Director of Engineering” at “IT Consulting Firm” in D.C (all of this from <https://ianreynoldsit.com/frontpage/>).

--Seth Rich begins work on DNC's IWILLVOTE project (specific date unknown).

--Seth Rich contacts Wikileaks (specific date unknown).

May 2014 – Seth Rich leaves Greenberg Quinlan Rosner.

June 2014 – Seth Rich joins the DNC as the National Data Director.

September 2015 – Josh Uretsky joins Bernie campaign as National Data Director, recommended by Seth Rich (according to Sanders in a Dec 2015 interview).

December 16, 2015 – NGP VAN applies new patch to DNC servers. According to email 15792 (reference can be found in Wikileaks), due to “a glitch in the code” the normal system barriers were lowered for FOUR hours and users could access other users data. This data could still only be accessed by other DNC user accounts. Four unique users ran and downloaded the results of 25 unique searches, saved to private hard drives and were removed from the premises.

Note: Urbetsky was unavailable for comment in the aftermath.

December 17, 2015 – DNC officials discover the person who accessed information was connected to the Bernie team and demand discipline of the individual.

December 18, 2015 – Bernie campaign fires Josh Uretsky, his campaign's National Data Director.

December 19, 2015 – (Saturday evening at 10pm) AMY DACEY reports the previous incident to Podesta (via Mary Fisher for some reason).

January 2016, –Sanders claims (in May 17 interview) that his Nevada HQ had shots fired and nearby employee apartments were ransacked.

June 12, 2016 – Bernie Sanders officially endorsed Clinton in Portsmouth, New Hampshire.

July 10, 2016 – Seth Rich is murdered in an apparent robbery with belongings left behind on his person.

July 22, 2016 – Wikileaks publishes 19,252 emails and 8,034 attachments from the DNC, including emails from seven key DNC staff members. The leaked DNC emails have a data range of January 2015 to May 25, 2016 – AMY DACEY resigns amidst controversy.

August 16, 2016 –The Chief of DC police conveniently exits stage left after only a month of the Seth Rich murder to some cushy insecure position with the NFL as “head of security”?

September 2016 – Wikileaks Craig Murry claims to have met a “disgusted” DNC staffer that was one of multiple sources of the obtained leaks (revealed in a Dec 14, 2016 interview).

September 16, 2016 – article <https://www.softwar.net/deplorable.html> by Charles Smith of “Softwar” titled “GUCCIFER 2.0 DNC DOCS – DEPLORABLE DNC” and dated september15, 2016. In this article, Ian Reynolds is labeled as “DNC technical staff member” and noting that Ian Reynolds was doing work then for the DNC on some problem associated with the DNC’s problems with the processing credit cards because the DNC systems “could not pass security tests required for certification.”

October 2016 – Wikileaks publishes PODESTA emails.

So here is Bernie’s Dec 26 interview about the event where he blames the DNC for recommending Josh Uretsky. He says that he was recommended by the DNC’s National Data Director.

From Claudia Kash: I know why Seth Rich had to die. There were 2 sets of polling places this primary season -- one set for most of the voters, who went on state websites to find their polling locations -- a second set for Hillary Clinton supporters who looked on Hillary Clinton's website to find their polling location. The Secretary of State for each state had one set of locations on the record; the other set of locations, the ones listed on Hillary's website, were not on the state record. I know this because I looked on her website to find where a friend should vote -- then double-checked the state website, which showed a different address. I thought there must be a mistake -- I kept checking, right up to election day. But until they killed Seth Rich, I couldn't figure out why there would be two different polling places. This is how I think the scam worked: While most voters look up their location on their state website, voters who were signed up as Hillary Clinton supporters would be directed to her site to find their polling place. It was set up the same as any other DNC polling place -- with DNC volunteers, regular voting machines, etc. -- and a duplicate voter roster, the same as the roster at the other polling place. Voters would be checked off on the roster, same as at the other polling place... and after the polls closed, the DNC supervisor would pick up the roster and the ballots.

The supervisor would then pick up the roster at the legitimate polling place and the ballots there. He(or she) would then replace a number of Bernie Sanders ballots with an equal number of the ballots from the Hillary Clinton voting location. Then the duplicate roster from the HRC would be shredded and thrown away, along with all the Bernie Sanders ballots that had been replaced. That way the number of people who voted (on the remaining roster) still matches the number of ballots. This is why so many states reported a "lower than expected voter turnout". Seth Rich, who was responsible for the app that helped voters find their polling places, did not realize that there were two sets of polling places until he himself went to vote. He lived in Washington DC, which voted at the end of the primary season, a week after Clinton had already been declared the winner. I believe he discovered it then, and had started asking questions about why the polling places on Hillary's website didn't match the ones on the DC website.

But even if he didn't say a word to anybody, it would have been dangerous to let him live. He would have figured it out sooner or later -- and he would have reported it when he did.


