1. Information We Collect

Taryn Barker: Demon Hunter **does not** collect or store personal data directly. However, third-party services integrated into the Game may collect certain data for functionality and analytics purposes.

Third-Party Data Collection

The Game uses the following third-party services, which may collect user data:

- **Firebase Analytics** Collects anonymized data on user interactions for app performance monitoring.
- Google Mobile Ads Serves advertisements that may use device identifiers for personalized ad targeting.
- Google Play Billing Handles in-app purchases through Google Play, which may process payment-related data.

2. How We Use Collected Data

We do not directly access, store, or use any personal data. However, the third-party services mentioned above may use collected data for:

- Improving Game performance and stability (Firebase Analytics).
- **Displaying advertisements** (*Google Mobile Ads*, unless the user purchases the "Remove Ads" option).
- Processing in-app purchases (Google Play Billing).

3. Advertisements & In-App Purchases

- Taryn Barker: Demon Hunter displays advertisements as part of its monetization model. These ads are provided by Google Mobile Ads.
- Users who purchase the "Remove Ads" option through Google Play Billing will no longer see advertisements.
- Google may collect data to serve relevant ads based on user preferences. Users can manage ad settings via their Google account.

4. Data Sharing

We do not sell, trade, or share personal data with third parties. Any data collected is handled by Google services as per their privacy policies.

5. Data Security

All third-party services used in the Game follow industry standards to ensure data security and encryption where applicable.

6. User Choices and Rights

- Mandatory Ads: Ads are shown unless the user purchases the "Remove Ads" feature.
- Opting Out of Personalized Ads: Users can manage ad preferences through their Google account settings.
- Disabling Analytics: Users may disable analytics tracking through device settings or by restricting app permissions.
- **Data Deletion Requests**: Since we do not collect personal data directly, users should refer to Google's privacy settings to manage their data.

7. Children's Privacy

Taryn Barker: Demon Hunter is not intended for children under 13. We do not knowingly collect personal data from children.
