- 1. Audit Committee Progress Status.
  - a. Tony reviewed the progress to date.

- 2. Ability Connection Services
  - a. The Council reviewed the site visit results.
  - b. A Motion was made and was carried to accept the proposal put forth by Tim Draney regarding moving forward with Ability Connection in developing an Agreement. Tim Draney and Kim Haggerty will serve as point persons.
