  - b. UC Davis
    - i. Reopening is going ok-ish? Really waiting to see what campus rates look like in the next week. But we're disappointed because no one is actively checking daily symptom surveys
    - Planning for how to use mental health funds from the state \$15 million ongoing funding split between campus (we're getting 1.7 million).
      Supposed to be focused on something new rather than expanding existing services <u>make sure that grad students are at the table!</u>

  - c. UC Irvine-
  - d. UC Los Angeles- Ernesto and Neda will be working to push for AB-369: This bill would authorize an enrolled Medi-Cal provider to make a presumptive eligibility determination for a person experiencing homelessness. The bill would require the department to reimburse an enrolled Medi-Cal provider who bills the Medi-Cal program for Medi-Cal services provided off the premises to a person experiencing homelessness, as specified.

UC San Diego-Campus is starting to enforce vaccine mandates; External team is working with the city planner to inform students about the city plan update, which will shape what the area around UCSD will look like over the next 10 years or so. We'll be advocating for more high density, affordable housing near campus.
- h. UC San Francisco-
- i. UC Santa Barbara- Ongoing Student housing crisis: most (all?) grads who reached out to GSA and/or Housing with housing concerns have been offered temporary housing through UCSB- the offers are not ideal. Are they acceptable? COVID reopening concerns: vaccination compliance high at UCSB; mask mandates; unanswered questions about enforcement of policies and protocols for if/when COVID cases increase. Graduate right-sizing committee ongoing: moving towards mandating departments to offer 5 years of funding. Pushing for re-allocation of block grant funding: to better support humanities and social sciences. Remote work option for grads: UCSB GSA submitted a proposal to Executive Council/Academic Senate to speak at the Faculty Legislature meeting late October. Summer stipends for grads: working with alumni association to fundraise for grad student summer stipends. GSA/UAW collaboration: ongoing conversations with UAW about collaboration re: campus safety.

  - a. Davis: has massive COVID testing capacity. Req vax folx to test every other wk, req unvax folx to test every 4 days. Waiting to see COVID rates in the next few weeks. Students have asked that teaching folx are not the ones responsible for checking symptom survey. Potential exposure emails are not very descriptive. Vax rate is >99% among folx coming to campus. Union is filing grievance for the folx who were denied remote teaching ops.

- b. Irvine: higher approval rate for being on campus. Online symptom checker is lax. Will be in touch with Eadie
- c. Los Angeles: will be in touch with Neda
- d. Riverside: not present
- e. San Diego: testing req for 4 weeks upon return to campus. Testing req for unvax. Admin is taking actions against those who are not compliant. 90% vax rate.
- f. San Francisco: mandatory vax, esp for students involved with patient care. City provides testing centers that are accessible to students, as well as UCSF's medical facilities
- g. Santa Barbara: vax is 98% for students, ~90% for staff. Waiting to see how cases will develop with students back on campus. Testing is no req for vax folx, up to students. Testing req 1/wk for unvax (mostly on religious grounds, some medical). Daily symptom screening is also online, has the right to see results of screening, but individual also has right to not show it; is confusing. Masking has been compliant and no issues yet. Housing is still an issue, students are temporarily housed at the moment.
- h. Santa Cruz: has self-reporting symptom checker; teaching can ask to see the results of the symptom checker, but little support from campus in terms of enforcement. Vax rate 89% for staff and 90+% for students. Testing is available. Working to ensure depts will allow grad students to chose their modality of teaching. Housing is difficult in Santa Cruz. Students feel disempowered.
