We are writing to invite you to join a campaign to bring the movement for labor rights in a closer relationship with the movement for a peaceful world. We invite you to sign the Open Letter ([bit.ly/VL4SPsignon](https://bit.ly/VL4SPsignon)) supporting The People Over the Pentagon Campaign. Mark Pocan and Ilhan Omar will be introducing a bill in 2025 to cut the Pentagon budget by \$150 billion, and make the money saved available to address climate change, healthcare, education, veterans benefits, and other pressing human needs.

**We also invite you to encourage your labor organization (or Veterans For Peace chapter) to endorse our Sample Resolution in support of People Over the Pentagon.** (Revise it as necessary to meet the needs of your organization and be sure to let us know when it is adopted. As of February 25, 2026, we are pleased to announce the support of **119 labor organizations and 37 Veterans For Peace chapters.**

The following 119 labor organizations representing more than 874,000 workers have endorsed the **People Over the Pentagon Act**, which was HR 1134 in the 2023-2024 Congress. That bill stipulated cutting excessive Pentagon spending by \$100 billion (11%). and making the money available to address pressing human needs such as health care, housing, education and veterans' benefits. The pay, benefits and health care of members of the military and veterans would not be cut. Our nation would be safer because the biggest threats to our security are economic inequality, racism, and climate change. The Pentagon has failed 8 consecutive audits, so we know that our tax dollars can be put to better use! Endorsed by Veterans for Peace. **Ask your labor organization to endorse the bill!**
