Abstract prepared with short sentences, clear, coherent, and systematic and can describe what and why research is done, how to do, and what the important results achieved from the study.

Keywords such important words in the abstract or words that often appear, at least 3 and a maximum of 5 terms separated by a comma in between

Introduction

The Introduction is written with Times New Roman 10 point. The introduction describes the background of the problem, research objectives, research limitations, methods used in the research, research results obtained previously and the contributions made from this paper

Literature Review

The Literature Review contains a systematic description of information on the result of research conducted by previous researches that is relevant to the researches to be conducted. This section contains the strengths and weaknesses that may exist in previous research which can be used as an argument that the research to be carried out is to perfect or develop previous research.

This sections also contains a theoretical basis in the form of a summary of theories taken from the literature that supports the research, as well as an explanation of the basic concepts and principles needed to solve problems. The theoretical basis can be in the form of qualitative descriptions, mathematical models or tools that are directly related to the problem being studied. The reference sources referred to in this section must be included in the sentence/statement referred to and in the reference, for example [1].

Table tittle written with Times New Roman 8 point, placed directly below symmetrically on the table, without ending with a dot sign. **Table should not be broken up**, unless it is impossible to type them into one page. On the continuation page of the table, the table number is listed and the word continue is written without a tittle. **Charts, graphs, maps, photos, they are all called images.** Image tittle in Times New Roman 8 point, directly below the

image, without ending with a dot sign. Image captions are written in the blank space on the same page. The scale and units on the graph should be as clear as possible. Every table and figure must be referenced in the paper.

Research Methods

This section contains a complete and detailed explanation of the steps taken in conducting this research. Besides, the research steps need to be shown in the form of complete and detailed flow diagram of the research steps of frameworks, including reflecting algorithms, rules, modeling, design and others related to aspects of system design.

Results and Discussion

The Results and Discussion section that contains all scientific finding obtained as research data. This section is expected to provide a scientific explanation that can logically explain the reasons for obtaining these results which are describes clearly, completely in details, integrated, systematic and continuous. The author organizes it systematically with rational arguments about the scientific information obtained in the research, especially information that is relevant to the research problem. The discussion of the research result obtained can be presented in the form of theoretical descriptions both qualitatively and quantitatively. In practice, this section can be used to compare research results obtained in research currently being conducted with research results reported by previous researchers referred to in this research. Scientifically, research results obtained in research can be in the form of new findings or improvements, confirmations or rejection of the interpretation of a scientific phenomenon from previous researches.

To clarify the presentation, the research results are presented carefully so that they are easy to understand, for example they can be shown in the form of tables, curves, graphs, pictures, photos or other forms as needed completely and clearly. Efforts need to be made so that when reading research result in this format, readers do not need to look for related information from the description in the discussion. The end of this section contains information about the system's strengths and weaknesses which are described in detail.

Conclusions and Recommendations

Conclusions are short, clear and precise statements about what was obtained, contain strengths and weaknesses, can be proven and directly related to the research objectives. The description in this section must be a statement that has been analyzed/discussed in the previous section, not a statement that is completely new and has never been discussed in the previous section and this an answer to the problem formulated. This section does not need any further explanation. The recommendations contain various suggestions or opinions that should be linked to the similar research. The recommendations are made based on weaknesses, experiences, difficulties, errors, new findings that haven't been researched and various possible directions for further research

The references contains are actually referred to the paper, written in Times New Roman 9 point, and it is arranged as follows:

1. Use supporting software such as : **Mendeley**, **Zotero** to *auto generate* the references.
2. The text for one reference is typed with one space, if the text of the reference exceed more than one line then the second line is typed with 6 space. The distance between each references remains of 2 spaces.
3. The reference sorces from the internet must from official scientific articles.
4. The references wrtitten should be according to:
 - a. **Book**: Author's name, tittle, edition (optional), volume (optional), publisher name, publishing city, year of publication
 - b. **Paper/Scientific Journal/Prosiding**: Author's name, tittle, name of paper/ scientific journal/prosiding, edition (optional), Publisher name, publishing city, year of publication
 - c. **Research Report**: researcher's name, tittle, type of research affiliator, city, year
 - d. **Internet**: Author's name, *tittle*, complete URL address. Publication on web besides e-book, e-journal, and e-proceeding not allowed to be used as a reference for scientific research and access date

- a. The topics that will published by **CYFORS** journal related to information technology, communication and computer with collection/accumulation of new knowledge, empirical observations or research results, and the development of new ideas or proposals
- b. Manuscripts received by editors are written in Indonesian standard or English and have never been published
- c. Manuscript was typed on a computer by Microsoft Word, on paper A4 (21 cm x 29,7 cm), margin 3-2,5-2-2 cm (left-top-right-bottom), width of each column 7,5 cm with spacing between columns 1 cm, font type Time New Roman size 10 point.
- d. Number of pages between 5 to 10, number of images should not exceed 30% of the entire content of the article
- e. If the paper is not the result of research then **Research Method** and **Results and Discussions** sections made into one part become **Discussions**
- f. The editor entitled to reject manuscript that do not meet technical criteria/requirements, changes to the stucture of the manuscripts, improve the language and consult with the author before the manuscripts is published.
