	and complies with the terms of this agreement. The Trustee accepts the Trust hereby created and
	agrees to carry out the provisions herein, without compensation, unless otherwise ordered.

4. **Miscellaneous.** The Trust being created shall be deemed to be an Ohio Trust, and shall be governed by the laws of the State of Ohio.
