- Receive occasional referrals without committing to fixed availability
- Stay fully independent while accessing agency infrastructure

What Affiliation Looks Like (Kaiser-Specific)

Affiliated doulas are **1099 independent contractors**, not employees.

You:

- Attract Clients with Kaiser Insurance
- Choose when you are available for Kaiser referrals

- Accept or decline Kaiser clients freely
- Maintain your own private-pay or non-Kaiser clients
- Work with other agencies if desired

We:

- Coordinate **Kaiser-eligible client referrals**
- Handle Kaiser billing and claims submission
- Support Kaiser-required documentation standards
- Provide THW-appropriate consultation and chart review

No required availability. No guaranteed volume.

- Be in good standing with the THW Registry
- Professional Liability Insurance
- Oregon Medicaid Provider ID - DMAP Number
- Meet Kaiser participation requirements (with agency support)
- Submit timely, accurate visit documentation
- Practice within THW scope and Doula Love guidelines
