Sub Judul 1

Subjudul dan isi dibuat berdasarkan topik pembahasan. Ditulis format paragraf, diketik 1,15 spasi, font time new roman 10,5.

Sub Judul 2

Subjudul dan isi dibuat berdasarkan topik pembahasan. Ditulis format paragraf, diketik 1,15 spasi, font time new roman 10,5.

Kesimpulan (10.5 pt, Time new roman)

Kesimpulannya harus berupa pengulangan singkat dari tinjauan pustaka. Ditulis dalam satu paragraf, diketik 1,15 spasi, font time new roman 10,5.

Konflik Kepentingan (Jika Ada, 10.5 pt, Time new roman)

Penulisan harus membuat pernyataan ada tidaknya konflik kepentingan.

Ucapan Terima Kasih (Jika Ada, 10.5 pt, Time new roman)

Ditujukan pada pihak yang membantu penelitian/penulisan.

Daftar Pustaka (10,5 pt, Time new roman)

Daftar pustaka ditulis menggunakan metode vancouver, minimal 15 kepustakaan dengan $\geq 80\%$ artikel terbitan 10 tahun terakhir. Diketik 1 spasi, font time new roman 10,5 pt dan disarankan menggunakan aplikasi *reference manager* seperti Mendeley, Zotero, atau EndNote.

The abstract in this section is in English, written in the form of one paragraph that does not exceed 200 words. The abstract summarizes the introduction, methods, results, and conclusions. For articles using Indonesian, the Indonesian abstract is written first, followed by an English abstract. If the article uses English, the English abstract is written first, followed by the Indonesian abstract. The abstract is written using Time new roman font 9 pt, single-spaced, and indented.

The introduction begins by identifying the topic, summarizing key points and ends with a clear statement of purpose. Written paragraph format, typed in 1.15 spaces, Time new roman 10.5 font.

Subheading 1

Subheading and contents are made based on the topic of discussion. Written in paragraph format, typed in 1.15 spaces, Time new roman 10.5 font.

Subheading 2

Subheading and contents are made based on the topic of discussion. Written in paragraph format, typed in 1.15 spaces, Time new roman 10.5 font.

Conclusion (10.5 pt, Time new roman)

The conclusion should be a brief reiteration of the literature review. Written in one paragraph, typed in 1.15 spaces, Time new roman 10.5 font.

Conflict of Interest (If any, 10.5 pt, Time new roman)

The author must declare whether or not there is a conflict of interest.

Acknowledgement (If any, 10.5 pt, Time new roman)

Addressed to those who assisted in the research/writing.

References (9 pt, Time new roman)

The references are written using the Vancouver method, a maximum of 30 references with >80% of articles published in the last 10 years. Typed in 1 space, Time new roman 9 pt font and it is recommended to use a reference manager application such as Mendeley, Zotero, or EndNote.
