- The introduction should be clearly identify the research problem, rationale of the study and context related issue in National and International
- Stated the gap of your study to show the significant of your study and reason why you need to conduct this study
- The theoretical framework should be described to guide the study. You may also present the overview of the conceptual model
- Explain the previous evidence related to your study in order to show the gap of literature with your study. You may also show the connection of variables with relevant theoretical and empirical evidence.

# **OBJECTIVE**

The objective should be stated clearly. Explain the main objective of your study

#### **METHODS**

The method of your study should consist of: **Design** 

The design of your study should be stated clearly, for example:

- Descriptive study such as cross-sectional/ Cohort/ Case Control/ Survey/
- Experimental study such as quasi-experimental/ Randomized Control Trial (RCT)
- Mix Method such as Sequential explanatory mixed method/sequential explanatory mixed method or etc.
- Qualitative study

# Sample size and sampling technique

In this part should consisted:

- Explain who the samples are, how many samples do you involve in this study with calculation of justification.
- Explain the sampling technique to recruit the samples
- Explain the inclusion and exclusion criteria for selecting the samples

### The instrument for data collection

The instrument for data collection consisted of:

- Clearly explain the instrument used of your study whether you develop, adapt or modify from previous study (Put the citation if you adapt of modify)
- Explain the component of instrument or item of the instrument, and its' scale for example Likert scale or Gutman scale

### Intervention (only for experimental study)

Clearly explain the process of intervention, what kind of intervention, frequency of intervention, and duration of the intervention. You need also to describe the type of intervention you implement for the control group.

# Data collection process

- Explain who collected the data. Any research assistants involves in this study and clearly explain the roles of those research assistant as well as the research coordinator

#### Data analysis

Clearly explain the type of statistic you apply to analyze the data. You may also describe the assumption before deciding the type of statistic

# **Ethical consideration**

Clearly explain the name of the ethics committee institution for approval of the study. You also need to state the informed consent process.

#### **RESULTS**

- The researchers were suggested to describe the characteristics of samples including age, gender, etc.
- In the results, the researchers should state the results follow the objective of the study. It also should be explain in concise
- The figure and table may show but not more than five table/figure

#### **DISCUSSION**

The discussion part was an important part of the study. It may consisted of:

- Explain the findings of your study and should be related to the theoretical model. Do the findings of your study similar of different with theoretical model
- Drawing new knowledge from your findings could contribute to theoretical development or previous findings.
- Stated the strength and limitation of your study (if any) and provides the implication for clinical practice and further research.
