1. Presentation of your VMG

Fintech: a new way for women's financial inclusion—is a project organized by members of the Women in Fintech Conference Committee, which is also represented by the University of Tirana, the University of Naples Federico II, the University of Prishtina "Hasan Prishtina", Kadir Has University (Turkey), Babeş-Bolyai University (Romania), the University of Oradea (Romania), the University of Pavia (Italy), Poznań University of Economics and Business (Poland), and University College Dublin (Ireland).

The project went through several stages and was completed on June 15, 2023. In the first stage, the drafting of the questionnaire was done. In the second stage, data collection was done; in the third stage, re-processing of the data and preparation of some preliminary results were done for Women in Fintech III. In the last stage, the preliminary results were presented at the Women in Fintech III conference. They will also be processed further, and a paper will be prepared.

Also, another purpose of this grant was the allocation of part of the funds for the Best WI-FI 2023 Young Researcher Paper Contest, in which students from all over Europe had the opportunity to participate. A jury was formed there, and with hidden votes, they voted for first place. Rosa Fabbriatore and Lucio Palazzo (from Università degli Studi di Napoli Federico II) won the Contest for the Best WI-FI 2023 Young Researcher Paper with the project entitled Multilevel IRT Models to Explore Heterogeneity in Subjective Financial Knowledge at Individual and Regional Levels: The Italian Case. This award includes a fast-tracked review and possible publication of the paper in Frontiers in Applied Mathematics and Statistics. Special Issue on Advanced Statistical Modeling for Fintech, financial inclusion and inequality (Guest Editors Maria Iannario, Branka Hadji Misheva, Jörg Robert Osterrieder, Claudia Tarantola), subject to prior agreement from the author or authors and being accepted by the editorial board of the journal.

Through this competition, we have encouraged all students (especially women) to participate in the conference, enabling them to create connections with other professors and continue further with the publication of their work.

The project is in line with the COST19130 Action objectives:

2. Main results/outcomes obtained

The main results from this WMG are presented in Women in Fintech III. VGM was planned to improve the role and opportunities for women in the fintech industry. This enables the researchers to contribute to the goals of the Action more easily and without incurring travel costs. The results presented in Women in Fintech III provided information about the opportunities that fintech can bring to women:

- ☐ Increase the level of responsibility for different institutions.
- ☐ Enhance cross-border collaborations between universities,
- ☐ Enabling participation in the Women in Fintech III conference
