This information is not personally identifiable and is used to analyze trends, manage the site, and gather demographic insights.

### **5. Session Recording & Analytics (Smartlook)**

We use third-party analytics tools, including **Smartlook**, to better understand user interactions and improve your experience.

Smartlook may record anonymized data such as:

- Mouse movements, clicks, and scrolling
- Navigation patterns
- Device and browser information

Smartlook **does not** collect:

- Passwords
- Payment details
- Personally identifiable information entered into secure fields

Data collected is used for service optimization, security, fraud prevention, and dispute resolution, in compliance with applicable privacy laws (including GDPR).
