- 1. Collect
- 1.1 Personal information we collect
- 1.1.1 When you use the display and browsing functions of works (referring to works expressed in the form of comic works and written works, the same below), we need to collect your device model and manufacturer, device screen information, device unique identifier, browsing device type and setting, language setting, operating system and application version, login IP address, network access method, network status, operator type, product version number, log information (such as operation log, service log), user ID, Browse related information and galleries with works. We collect this information to provide you with our core works display, browsing, and information display services. If you refuse to provide it, you may not be able to use our services.
- 1.2 Personal information collection method
- 1.2.1 In order to provide services, we will collect your personal information in the following ways.
- · (1) To collect the information you voluntarily provide when you register as a member or use Comic Toon services.
- · (2) To collect information provided to us by partner companies.
- (3) Collect information that is automatically generated during your use of Comic Toon services.
- 1.3 Matters concerning the installation/operation and refusal of the automatic collection device of personal information
- 1.5.1 Purpose of Cookies
- · In order to provide users with the best information services in order to understand the services you use, the websites you visit, how they are used, and the scale of users.
- 1.5.2 Cookie setting/operation and refusal to save
- · You have the right to choose to set cookies, and you can allow or refuse to save cookies through the options provided by your browser and OS. However, if you choose to refuse to save cookies, you may not be able to use some of the services you need to log in.
- 2. Save and delete
- 2.1 Where the information is stored

We abide by laws and regulations and store personal information collected in China in China.

- 2.2 Duration of stored information
- 2.2.1 In principle, we only keep your personal information until you quit the service or the entrustment contract is terminated.

2.2.2 Generally speaking, we only retain your personal information for the shortest period necessary to achieve the purpose.

However, in the following cases, we may change the storage period of personal information to comply with legal requirements:

- (1) To comply with applicable laws and regulations and other relevant provisions;
- (2) To comply with court judgments, rulings or other legal procedures;
- (3) To comply with the requirements of relevant government agencies or legally authorized organizations;
- (4) We have reasons to believe that we need to abide by relevant laws and regulations;
- (5) Reasonable and necessary purposes for the implementation of relevant service agreements or this policy, safeguarding social and public interests, and protecting the personal and property safety or other legitimate rights and interests of customers, affiliated companies, other users or employees. - 2.3 You have the right to delete your information

You have the right to have us delete the relevant information we have collected by submitting account cancellation. After the information is deleted, we will not retain the relevant information. You can also contact us by email to delete.

The next time you use related services, you need to re-authorize us to collect relevant information so that you can use the services we provide. In order to facilitate your use of the services we provide, we will continue to store the information you have provided unless you delete it.

- 3. Application
- 3.1 Sharing and provision of personal information

Except for the case of providing information between us and our affiliated companies, your personal information will not be provided to the outside without your consent. However, the following cases are exceptions.

- (1) With your prior consent;
- · (2) When prescribed by law.
- 3.2 Use of personal information
- 3.2.1 We strictly abide by the provisions of laws and regulations and the agreement with you, and use the collected information for the following purposes. If we use your information beyond the following purposes, we will explain to you again and obtain your consent.
- · (1) Provision of services;
- (2) To meet your individual needs;
- (3) Product development and service optimization;
- (4) Safety guarantee;
- (5) Recommend information that may be of interest to you;
- (6) Evaluate and improve the effectiveness of our advertising and other promotions and promotional activities;
- (7) Management software;
- (8) Invite you to participate in surveys about services.
- 3.2.2 During the process of using the service, you can access, modify and delete the registration information and other personal information provided by it, and you can also contact us according to the notification guidelines. The scope and method of your access,

modification and deletion of personal information will depend on the specific services you use. When you access, modify and delete relevant information, we may require you to perform identity verification to ensure the security of your account.

- 3.2.3 We will collect and use your information only to realize the functions of products or services as described in this policy. If you find that we have collected and used personal information in violation of laws, administrative regulations or the agreement of both parties, you can request to delete it. If you find that the personal information we collect and store is wrong, you can also request correction. Please contact us through the contact methods listed in this policy.
- 3.2.4 When you use the service, we may send you emails, text messages, news or push notifications. You can choose to unsubscribe on your device by following the relevant prompts.
- 3.2.5 When necessary, we may issue service-related announcements to you.
- 3.3 Sharing of personal information
- 3.3.1 With your prior consent, we may share your personal information with third parties.
- 3.3.2 With the continuous development of our business, when mergers, acquisitions, asset transfers and other transactions lead to the sharing of your personal information with third parties, we will notify you of the relevant situation through push notifications, announcements, etc., in accordance with laws and regulations and Continue to protect or require a new manager to continue to protect your personal information at a standard not lower than that required by this policy.
- 3.4 Your rights and how to exercise them
- 3.4.1 You may view or modify your registered personal information at any time, withdraw your consent, and request to cancel your account.
- 3.4.2 When you request to correct errors in personal information, we will not use and provide such personal information until the correction is completed. If wrong personal information has been legally provided to a third party, we will immediately notify the third party of the information to be corrected to ensure that the information can be corrected.
- 3.4.3 When you make a request to us in accordance with the "retention and deletion" clause, we will suspend or delete the requested personal information. We promise to process the content stated in the information and not use it for other purposes.

- 4. Public Disclosure

In principle, we will not publicly disclose your personal information without your prior consent. However, we may disclose your personal information for the following purposes:

- (1) Comply with applicable laws and regulations and other relevant provisions;
- (2) Comply with court judgments, rulings or other legal procedures;
- (3) Comply with the requirements of relevant government agencies or other legally authorized organizations;
- (4) There are reasons to believe that laws and regulations and other relevant provisions need to be complied with;
- (5) Reasonable and necessary purposes for implementing relevant service agreements or this policy, safeguarding social and public interests, protecting the personal and property safety of our customers, us or our affiliates, other users or employees, or other legitimate rights and interests.
- 5. Information Security

We provide appropriate security safeguards for your information to prevent loss, improper use, unauthorized access or disclosure.

- (1) Strictly abide by laws and regulations to protect your communication secrets.
- (2) Various security protection measures will be used within a reasonable security level to ensure the security of information.
- (3) Establish special management systems, processes and organizations to ensure information security.
- (4) In the event of a security incident such as the disclosure of your personal information, we will activate an emergency plan to prevent the expansion of the security incident, and notify you in the form of push notifications, announcements, etc.
- 6. Scope of application
- 6.1 This policy applies to all our services.
- 6.2 The collection of personal information by other companies through links within the service does not fall within the scope of application of this policy.
- 7. Terms for minors
- 7.1 If you are a minor under the age of 18, you should read and agree to this policy under the supervision and guidance of your parents or other guardians before using our services.
- 7.2 We protect the personal information of minors in accordance with relevant national laws and regulations, and will only collect, use, share or disclose minors' personal information when permitted by law, with the explicit consent of parents or other guardians, or when it is necessary to protect minors Personal information; if we become aware that personal information of minors has been collected without prior verifiable parental or other guardian consent, we will attempt to delete the information as soon as possible.
