**Church Ceremony: Holy Cathedral River North (\$2,250)**

- 720 N Wabash Ave, Chicago, IL 60611
- **Submit music selection 1 month prior to [music@holynamecathedral.org](mailto:music@holynamecathedral.org)**
- **Couple does not want a ceremony seating plan other than the first row being designated for immediate family**
- **Rehearsal times on Thursday: 5:30-6:15 or 6:15-7PM. Please arrive 15 minutes prior**
- **Attire: there are no written dress requirements but they expect vendors to wear “church appropriate clothing”**
- **There is a rehearsal scheduled after the couple at 5:15**
- Church has the ability to livestream for \$300
- Timeline notes:
  - Bride + bridesmaids can enter 45 minutes prior to start time
    - **Bride cannot change on site. This is not to be used as a dressing room**
    - Bride – elevator to lower level to bridal room
    - Groom – introduce yourself to the coordinator/security for entrance to sacristy
    - Parents to stay in back greeting guests
    - \*HNC coordinator needs rings + Virgin Mary posey
  - Ushers to seat guests 25 minutes before start time
  - 10 minutes before: prelude music begins
    - Bride to wait in the alcove outside the elevator (dad will join here)
    - Bridesmaids will line up in the outer foyer of the church
  - 5 minutes before: groom at front of church or in back waiting
    - Bridesmaids/groomsmen paired or grooms in standing position up front
  - Procession:
    - Groom’s Grandparents, Bride’s Grandparents,
    - Parents of the Groom (Groom may walk with them),
    - Mother of the Bride w/escort)

- Bridal Party/Attendants
- Maid of Honor/Best Man
- Flower Girl/Ring Bearer
- Bride w/Father of Bride (or both parents or other escort)

Notes:

- brides room has to be cleared of all personal possessions before the ceremony or immediately after
- photos in the cathedral can only be bride and groom, bridal party and immediate family (extended family or friends is not allowed)

**Venue: Chicago Illuminating Company (\$13,500)**

- Deposit of \$8,100 paid on July 19, 2025
- Balance of \$5,400 + security deposit due September 24, 2026
- COI required for all (look at page 9 of the contract)
- Entire space + outdoor courtyard / tented
  - Vendor load in 8AM / load out 12AM-1AM
  - Overtime – no charge
  - Guests arrive at 5:30PM for cocktail hour and 6:30PM for reception
- **Exclusive caterers only. Outside food vendors not allowed except cake/dessert or pre-approved food trucks with conditions**
- **Security based on final guest count, 2 required at \$40 per hour per officer with a 6 hour minimum.**
- **Security staff starts 1 hour before guests arrive and ends 1-2 hour post the bar closing**
- **2 officers will be required based on our guest count and are included in the vendor meals**
- **A maintenance fee is basic pre and post event clean up and prep of indoor space and the tent structure**
- If we want lighting/staging we must work through Frost Lighting Company of IL
- Must get approval for all décor elements (signage, displays, etc). Anything left behind will incur a fee
- Heating and heaters are included in the rental fee and will be onsite based on the weather conditions
- Disco ball is allowed and can be installed at additional cost of \$650 (all inclusive of labor, delivery, etc)
- **Couple must obtain general liability insurance for 1M**
- If auxiliary needs are required we must submit a request with one week advanced notice
- No open flame, in hurricane only
- Not allowed: hooks, nails or screws, staples, glitter, confetti, fake snow, rice, etc. Fog, haze and sparklers require approval
- Smoking is not permitted at anytime. Only in the courtyard annex and the alley to CIC
