

Terms of Use (End User License Agreement)

- **Overlay & Notifications:** To display effects over other apps.
- **Phone State:** To trigger effects during calls.
- **Storage:** To allow you to set custom backgrounds.

You acknowledge that denying these permissions may limit the Application's core functionality.

3. User Conduct and Restrictions

You agree **not** to:

- Decompile, reverse engineer, or attempt to extract the source code of the Application.
- Use the Application for any illegal or unauthorized purpose.
- Modify, adapt, or create derivative works based on the Application.
- Use the Application to infringe upon the intellectual property rights of others.

4. Intellectual Property
