## **Olympic Community of Health**

The Olympic Connect Advisory Group is a collaborative that provides recommendations to OCH staff and Board of Directors on a myriad of functions and elements of the community care hub. A regional advisory group helps build buy-in, trust, and ensures that the hub meets its goals and objectives in an inclusive and collaborative manner. The Advisory Group hears and considers big picture updates as well as the **5 core functions of a community hub.** 

- <u>Community Voice & Engagement –</u> Establishing community buy-in, trust, and partnerships to address social and health related needs. Includes implementing a community advisory and governance structure that defines priority populations and community needs/gaps.
- <u>Sustainability & Business Operations –</u> Creating sustainable and accountable foundation to support network of partners. Includes strategic measurement and reporting, fund development, staffing, and processes to further community health improvement.
- <u>Care Coordination Operations & Reporting –</u> Define community-based care coordination approach and standards to support a network that helps people get the services they need to improve health. Includes workflows, IT systems, process improvements, data privacy and security, and interoperability with other hubs.
- <u>Network Management & Capacity Building –</u> Capacity assessment and building of trusted partners in community to ensure the network reflects community priorities and needs. Includes technical assistance and training for hub partners.
- <u>Community-Based Workforce</u> Assessment of workforce needs and plan to engage, develop, and grow community "connectors". Includes training and convening.

This group does not make decisions or direct the work of staff, or the organization, yet serves in an advisory capacity. The OCH Board of Directors will hear group recommendations, have their own robust discussions, and has the authority to direct the work of the organization. Current members have committed to participate through 2024 and will reevaluate the group for 2025 and beyond.
