IV. Discussion Items

A. **Discussion Item 1**: Testing Season and MAP Data

Dr. Danser presented an overview of the data. Concerns discussed include the difficulty of having come off a particularly successful year of EOC data which counts so heavily toward CCRPI, and now our target is set even higher. Dr. Danser reviewed the MAP data and discussed whether or not they are a reliable indicator of success on EOC's. Suzanne Mitchell asked for clarification on how valuable the MAP testing is at MJHS. Dr. Danser discussed how it is somewhat a predictor of achievement for Milestone, but as students get older, it ceases to be as reliable- whether because students stop taking it seriously or it is harder to show growth at the higher levels. Ms. Galloway added that it is used as a screener for Gifted testing. Dr. Danser then discussed how there exists a literacy challenge which is reflected in the orange and red on the growth and achievement MAP chart on the presentation. Our overall CCRPI scores on the GOvernor's Office of Student Achievement was 81.7, which is the highest it has ever been for our school. We also marked another year of MJHS Beating the Odds, and we scored high on school climate. Dr. Danser then opened up the floor for the GO Team to discuss the data. Nancy Lamb asked a clarifying question about growth data form Math. Suzanne Mitchell pointed out that our strengths were our ongoing consistency, and the real question was how do we use consistency to catapult growth? We have a baseline, so how do we discuss growth from that. Nancy Lamb brought up - in terms of opportunities for growth, while we have them in 9th grade, we have an opportunity to intervene for growth for those kids who get to us at a lower level at the 9th grade level. Dr. Danser also pointed out that he was particularly proud of the growth we have seen in this data. Cartee Lewis brought up there was an even greater opportunity for those kids in the orange that could go either way.

B. Discussion Item 2: Needs Assessment

Mr. Duncan brought up how the Jaguar Learning Lab has proved to be very effective. Dr. Danser asked if the GO Team had any ideas about different ways to reach the parents. Nancy Lamb asked is there a program we have access to that allows students to improve by working on at home? He brought up Khan Academy, Delta Math, and College Board. The problem ends up being the kids who need it the most are not using them. Next year, we are using LEXIA curriculum resources with the new ELA curriculum. Suzanne Mitchell brought up the question of how we are using coaches with extracurriculars as a place of support for the kids. Dr. Danser responded that most coaches are using their position to connect and leverage that experience to encourage improvement. Suzanne Mitchell brought up perhaps we should expand it to clubs as well. Cartee Lewis said we should be proud of our CCRPI numbers
