CONDITIONAL FORGIVENESS VIA REMEDYCOIN PROCESS

These serious matters are being addressed in a manner which brings settlement via a non-taxable negotiable forgiveness contract. The combined value of the damages has been considered to such an amount which I deem appropriate considering I will conditionally pay the price of the damage from my own self through my heart's forgiveness forged from my own infinite personal worth.

The conditional offer is this:

Through forgiveness, and this contract with your tacit agreement we convert the value of the damage into a commemorated asset value of forgiveness.

I shall be permitted to tokenize the value of this commemoration as Remedy.Baker and attach such to the Bitshares blockchain so that I may sell digital fractions of this commemorative token to achieve remedy to some degree. Estimated costs of achieving remedy have been added to the costs of the damage.

Your role as recipients of this notice is to be aware of the injury and that you have not yet provided this process and if you deem necessary, object to the commemoration of.

It is Joseph's intention to put the respondents in honor if they do nothing. By not objecting in the manner specified it shall be deemed that respondents' tacit agreement has been secured to receive forgiveness and for Joseph's automatic act of forgiveness to commence, for Joseph to be allowed to commemorate his act of forgiveness by creating tokens on a blockchain.

TIME LIMIT AND MANNER OF ACCEPTABLE OBJECTION

15 days will be allowed for your objection. A notice of default will then be issued and opportunity to cure the default by providing an extension of time by two more days. If no objection is registered by then your tacit agreement shall be deemed to have been secured.

MANNER OF ACCEPTABLE OBJECTION

In order to have a fair, independent, decisive and trustworthy signal Joseph chooses a Bitcoin transaction to be the manner which will signal whether the respondents object. Any objection using any other means of communication lacking a transmission of value to the specified Bitcoin address shall be deemed defective on its face.

FALSE ARREST

Police officers Patrick Lefler and Richard S. Davis Jr. did falsely arrest me without cause inhibiting me from exercising my life, liberty and pursuit of happiness. My life became in danger hanging by a thread as the intent of officer Richard S. Davis, Jr. was clearly expressed when he said "I think he shot himself" and then began stomping on my head. Thus the False Arrest was in fact also at a MINIMUM putting my life in danger.

ATTEMPTED MURDER, KIDNAPPING, TORTURE, USING FORCE TO COMPEL COMPLIANCE, INTENT TO DEFRAUD, CONCEALMENT OF RECORDS, WITNESS TAMPERING, WAR CRIMES

Officers Patrick Lefler and Richard S. Davis, Jr. had self imposed duties by their oaths of office to protect the life, property, freedom of speech, liberty and the ability for others to peacefully assemble. Instead they impeded the ability to assemble, attempted to murder myself by stomping on my head until their supervisor arrived at the scene, used force to compel me to follow unlawful demands. Concealed the true nature of Driver's Licensure and automobile license plate registration in the police report by omitting details from the police report with an intention to defraud me, defraud the court and defraud Barnett's Towing company enjoining them

into an act of theft and racketeering based on the false testimony of a police officer. I did have a valid Wisconsin Drivers License and his vehicle had valid Wisconsin Registration in contradiction to the officer's charge that I had no valid License.

Numerous acts of torture involved forcing me to walk in severe pain from having been clubbed 15 times with batons and stomping on his head three times. Forcing me in this state to sustain myself in a 2.5 foot square room for many hours unattended as retribution for failing to cooperate with intake personnel by withholding a social security number, address, signature, birthdate, name, etc..

The Kern Medical Center in concert with the Bakersfield Police Department while holding me prisoner against my will had a duty to provide food and water yet at the direction of the head nurse who withheld water and comfort as I cried out for it 35 times as I sat in the waiting room of the Emergency Intake area. The head nurse responded after the 35th time "Well if you hadn't knocked over an officer" indicating that denial of water was being done to inflict retribution without judicial oversight (as I had discovered there was no judge on duty at this late hour after my head was stomped on - I had appealed a legal determination made by Patrick Lefler and his superior officers to learn there was no judge on duty to appeal to.)

Witness Tampering - I was a witness to a California civil action S1500CL237061. A witness to many actions of fraud in the Kern County Courts involving a cast of characters including GMAC Mortgage, ETS Services, Joe Devers, REO Properties Corporation. name was used as a plaintiff used an ex-convict named Joe Deveres to swear to serving notice to Star Hills in a foreclosure case

FAILURE TO PROVIDE HANDICAPPED ACCOMMODATIONS

After striking me with 15 blows of a police baton on knees, ankles, near testicles, kidneys, buttox it was unbearable pain to move yet over and over again I was forced to walk from place to place rarely getting a wheelchair. In jail, I was placed in a 2.5 foot square room where I could not sit and left there for numerous hours. When I begged for a chair I was told "If you won't cooperate with us we won't cooperate with you. I informed the officer that it was his job to accommodate me. Yet he left me there for hours and left his shift. The next shift of officers came in and were asking me what I was doing in there?

RECEIVING COMPENSATION

Your opportunity of providing compensation for these acts has come to an end. A government may not steal from taxpayers to atone for its sins. Hence Joseph will atone for these atrocities himself providing an example to the world of how a commemorative economy might work. If any of the parties feel they wish to participate in providing remedy to Joseph, they should buy the commemorative tokens when Joseph makes them available for sale after the time for objection has past.

CONDITIONAL FORGIVENESS

If none of the respondents transmit an objection signal to the Bitcoin Blockchain the deadline

and potentially a courtesy extension of time, the numerous sins of respondents will be deemed automatically forgiven by Joseph.

FINANCIAL INSTRUMENT EXPERIMENT

It is Joseph's conviction that this notice represents a highly moral, ethical, streamlined procedure for resolving conflict with a minimum of resistance. The resulting financial instrument is a settlement of a dispute and thus is immune from securities law.

It should be understood that the respondents' reputations shall be immutably be recorded on the Internet if there is no objection to this process. That being said, the reputation is what it is anyway.

Due to compartmentalization a police officer is not trained to understand the foundations of the laws and code they are hired to enforce. They are trained to simply obey their supervisors and respect the opinions of lawyers and judges - trust the "authorities" in this matter. However in my personal review of the work of Marc Stevens at <http://MarcStevens.net> of perhaps 50 cases where people have exercised their rights to discovery for any evidence supporting the presumption that government codes, laws and constitutions apply to a human being who is geographically within a "political boundary" -- no such evidence has ever been brought forth. Even a state supreme court judge was unable to produce any evidence supporting this underlying presumption. So present some evidence that the laws and codes apply just because one is inside the borders by the aforementioned deadline or my perception that your actions as a "government" are deemed to be fraudulent. NARRATIVE

The events commencing on or about September 28, 2009 at 3:00 a.m. were caused by the first wrong deed of Bakersfield Police officers arresting Joseph by turning on their Red and Blue flashing lights without cause in an alleyway where Joseph was attempting to locate his destination and to ascertain whether a parking location might be obtained.

The actions of Patrick Lefler and Richard S. Davis Jr. appear to be acting as agents for a jealous man Mr. Davis - owner of Red Barn Karaoke service and the owner of a band which employed Giery Boyd. Giery Boyd had hours earlier met Joseph singing Karaoke on the Band's night off in celebration of something. Giery and Joseph sang to each other and danced with each other experiencing great feelings of love. Giery had given Joseph her telephone number, instructing him to call her later in the evening as she had another party to attend. During the phone call, Giery invited Joseph to come over to spend the night to cuddle only. SEE EVIDENCE RECORDING.

Officers Davis and Lefler had a duty to protect Joseph and Giery's action of peaceably assembling according to their duties as peace officers of the Bakersfield Police department. ~~However these officers were agents of one other Mr. Davis, owner of Red Barn Karaoke who it is alleged by Joseph to have contracted by money or favor with the officers to stop Joseph from arriving at Giery's door.~~

False arrest occurred as the officers without cause turned on their red and blue flashing lights.

At the traffic stop, Joseph was asked to get out of the car and sit inside the rear seat of the police car which Joseph did do. But Joseph kept his feet outside the police vehicle as he did not wish to be locked up as it appeared to Joseph to be a false arrest since officer Lefler's only explanation of the "emergency" was that Joseph was driving too slow which is not an arrestable offense in a parking lot.
