

Privacy Policy

This Privacy Policy describes how Humzy ("Developer") collects, uses, and protects personal information obtained through the use of Nakama Stocks ("Bot"). By using the Bot, you consent to the practices outlined in this Privacy Policy. If you do not agree to this Privacy Policy, please refrain from using Nakama Stocks.

Information Collection

User-Provided Information: When you interact with Nakama Stocks, the Developer may collect certain personal information, including but not limited to Discord user IDs, server IDs, and any other information you provide voluntarily.

Usage Information: The Developer may collect information about your interactions with Nakama Stocks, including commands used, server activity, and other usage data. This information is used for statistical analysis and to improve the functionality and user experience of Nakama Stocks.

Use of Information

The Developer uses the collected information for the following purposes:

- to provide and maintain Nakama Stocks' functionality and features;
- to respond to inquiries, support requests, and provide assistance;
- to personalize and enhance the user experience of Nakama Stocks;
- to monitor and analyze trends, usage, and activities related to Nakama Stocks;
- to detect, prevent, and address technical issues, violations of terms, or fraudulent activities; and
- to comply with legal obligations and protect the rights, property, or safety of the Developer and Nakama Stocks users.

The Developer does not sell, trade, or rent personal information collected through Nakama Stocks to third parties without your explicit consent. However, the Developer may share non-personally identifiable information with trusted third-party service providers to facilitate the provision of Nakama Stocks' services or for statistical analysis.

Data Storage and Security

The Developer takes reasonable measures to protect the personal information collected through Nakama Stocks from unauthorized access, disclosure, alteration, or destruction. The personal information collected through Nakama Stocks is stored on secure servers or trusted third-party platforms, which may be located in different countries. By using Nakama Stocks, you consent to the transfer of your information to these locations.

Data Retention
