BVSD Title IX Advisory Council

Description

Updated March 23, 2021

This is a new initiative, and expected to evolve. This document will be updated regularly.

Purpose

Ending sexual harassment and violence and equipping students with the knowledge and awareness necessary to do so requires collective action. In order to develop systems and programs that meet the needs of students, BVSD establishes a Title IX Advisory Council with the specific purpose of elevating student voice.

Through equitable representation, BVSD's Title IX Advisory Council reviews and make recommendations to the School District's Title IX Compliance Officer(s) and BVSD staff regarding the School District's policies, procedures, and initiatives addressing sexual violence and harassment. This includes:

- Identifying best practices for addressing sexual misconduct, including establishing a
 healing-centered approach for people who have experienced sexual harassment or sexual
 violence
- Providing input on the District's policies and procedures that address sexual violence
- Identifying the needs, issues, and climates of school campuses and technology platforms with regards to issues of sexual violence
- Reviewing programming, training opportunities, and educational materials regarding sexual misconduct to be made available to schools, staff, students, and the community
- Raising awareness about ongoing efforts to reduce sexual violence

The committee will not have responsibility for, or involvement in, investigation or resolution of specific cases or day-to-day District operations.

Composition

The Council will include BVSD staff, parents, students, and community partners. As part of BVSD's commitment to equity, the Council must include members from marginalized communities and those who have been impacted by sexual violence and harassment. Members may be self-selected or recruited. It is anticipated that the Council will have 15-35 members, depending on interest.
