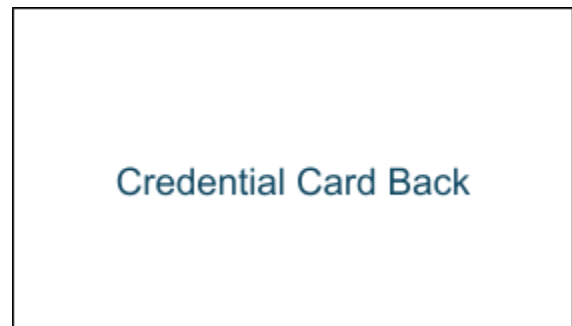
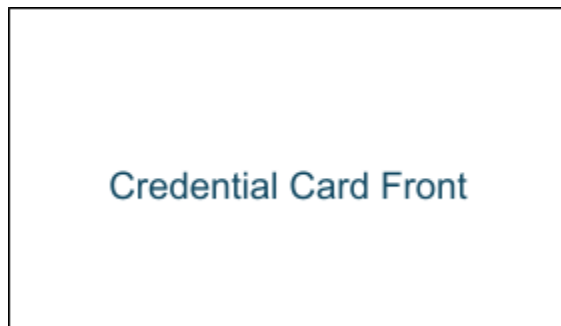

1. I am a natural-born national of the pre-Civil War state known as California but not a citizen of the United States;
2. I claim my guarantees and protections under both The Constitution of the United States and The Constitution of the United States of America, my lawful political status, and my exemptions from levies, taxes, and performances imposed on foreign citizens;
3. My claimed exemptions include but are not limited to exemption from service levies, press-ganging, conscription, impoundments, drafts and other forced military, mercenary, and/or "civilian military" service performance requirements;

4. My guarantees claimed include but are not limited to all natural property rights, including but not limited to my body, blood, and DNA, my names and persons, my intellectual property rights, private labor performances and all consideration derived from these sources;

5. My claimed protections include but are not limited to freedom from legal presumptions applied to foreign citizenries, freedom from impersonation and foreign enfranchisement, and removal of all and any land assets held in my name from foreign tax rolls and data bases, title systems, land description systems, land surveys and trusts;

6. I am at peace with the British Crown and the Holy Roman Empire and their Successors, owing them no administrative service or validated debt that is not eligible for Mutual Offset Credit Exchange Exemption or discharge;

7. I exercise my right of self-determination and freewill without coercion or restraint and hereby rely upon your goodwill, honor, and good faith service obligations to secure my identity, correct all records related to my name, and return my assets without harm;
