#### <u>Introductions</u>

Industry members introduced themselves.

### Purpose of Meeting

The purpose of the meeting is to review course curriculum, competencies, and their relationship to current industry practice. The Education Pathway Program of Study was reviewed in detail including Introductory, Concentrator, and Capstone courses. Teacher provided an overview of the courses.

### **Review and Approval of Minutes from Previous Meeting**

Status of previous recommendations are pending (newer textbook versions, dual enrollment).

#### **Curriculum Review**

Reviewed textbooks as well as supplemental items that were purchased. Discussed the curriculum (Careers, Investigations) and how it pertains to "real life" experiences that prepare students to work in law enforcement. Discussed new curriculum items, defensive tactics, physical fitness, baton, chemical agents. Defensive tactics are being taught to improve student confidence and to improve their ability to confront others in a more relaxed state. Physical

conditioning exercises are held one day per week and focus on key areas such as core and lower

joints and flexibility. There is also a big focus on interpersonal communications and

de-escalation. Students are exposed to scenarios where they must demonstrate their ability to

de-escalate rather than utilizing a weapon. There has been focus on ground control techniques

where the subject is held / secured rather than struck with a fist or baton. There was a review

of student portfolios that contained applications, resumes, BST (behavioral skills tests) and

training records. Additional equipment purchased was reviewed. Competencies also reviewed.

**Dual Enrollment** 

Currently students enrolled in Child Development 1 as a dual enrollment course for the Fall

Semester. 20 Students are dual enrolled from Clovis North High School.

24 Students are dual enrolled from Clovis High School, which is an online course. Students have

taken their mid-term.

**Review of Relevant Data** 

Discussed the students from last year who passed the Para-professional exam, and the dual

enrollment course.

Discussed students who are currently working for CUSD from program.

**Work-Based Learning** 

Cynthia Huerta shared the Community Classroom placements for CHS students at the following

locations: Andres Day Care, Bright Beginnings, and New Life Discovery Center

Have dual enrollment on Clovis Unified School sites.
