5. Clinical Requirements: At least 72 hours Hospital and 72 EMS hours for EMT, at least 96 hours Hospital and 96 hours EMS for AEMT (**24 of EMS hours will be Capstone hours**) providing all your required skills are met, and for Paramedic at least 192 hours Hospital and 360 hours EMS (**120 pf EMS hours will be Capstone hours**). You may have to do more to satisfy the requirements of the program.
6. Clinical Paperwork (for prehospital) To be done completely on GEMSA LMS system, Pertinent information and any skill or Medication also to be done on Platinum Planner to ensure credit is given for those things you do. (NOTE)... Copy and paste your narrative to save time. **All paperwork and required documentation is to be uploaded into the system no later than 24 hours at the completion of your clinical shift. Late assignments will result in a reduction in your clinical grade for the day. Example late over 24 hours will be 70 for your grade and later than 48 hours will result in the clinical being voided, no time or skills credit given, and you will be required to redo the**

clinical. The only exception to this rule is in emergencies and cleared /approved by the Program Director.

7. Drug screen: You will be required to go get a drug screen done as set up by the program prior to any clinical time being assigned.
8. Background Check: You will be required to do have a background check completed by the organization set up by the program prior to any clinical assignment.
9. Hospital Clinical/ EMS Clinical Packets: as of this point we have the following sites clinicals will be able to be completed.
 - a. Blue Ridge Medical Center (formally Fannin Regional Hospital), (agreement in place, student requirements must be met)
 - b. Northside Cherokee Hospital (Agreement in place, student requirements must be met and at least ½ of clinicals for hospitals will be conducted here. AEMT only)
 - c. Union General Hospital (agreement in place) you will have a packet of information to go through, complete, sign, turn in and their medical vaccinations / waivers to contend with.
 - d. Union General EMS (affiliation agreement signed and uploaded to state).
 - e. Fannin County Fire Rescue/ EMS Hosting and available for clinicals at station 1 and 11
 - f. Towns County Fire Rescue (affiliation agreement signed on 3/1/2022 to be executed and uploaded on 3/2/2022).
