Halcyon Fitness Data Privacy Policy
This Privacy Policy describes how your personal information is collected, used, and shared when you visit or avail of our services.
PERSONAL INFORMATION WE COLLECT
<p>When you visit the Site, we automatically collect certain information about your device, including your web browser, IP address, time zone, and some of the cookies installed. Additionally, as you browse the Site, we collect information about the individual web pages or products you view, websites or search terms that referred you to the Site, and information on how you interact with the Site.</p> <p>This personal data will be retained only for as long as necessary and for the following purposes: to fulfill our declared services; to establish, exercise, or defend legal claims; or for legitimate business purposes consistent with standards followed or approved by the applicable governing body. We refer to this automatically-collected information as "Device Information."</p>
We collect Device Information using the following technologies:
<ul style="list-style-type: none"> - "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier. For more information about cookies, and how to disable cookies, visit http://www.allaboutcookies.org.
<ul style="list-style-type: none"> - "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
<ul style="list-style-type: none"> - "Web beacons," "tags," and "pixels" are electronic files used to record information on how you browse the Site.
<p>Additionally, when you avail of our services through the Site, we collect certain information, including your name, email address, payment information (credit and debit card numbers), phone number, and recipient's email address and contact number. This information is kept for a maximum of (# of days or # of months), after which it is removed from our database. We refer to this information as "Medical Service Availment Information."</p>

When we talk about “Personal Information” in this Privacy Policy, this refers to both the Device Information and Medical Service Availment Information.

HOW DO WE USE YOUR PERSONAL INFORMATION?

We use the Medical Service Availment Information that we collect generally to fulfill any medical services availed through the Site (including processing your payment information, recipient's email address/phone number/s and/or medical services confirmation). Additionally, we use this Medical Service Availment Information to:

Communicate with you;

Review medical services you availed; and

If it is in line with the preferences you have shared with us, provide you with information or advertising relating to our services.

We use the **Device Information** that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our marketing and advertising campaigns).

Retention of Device Information for a certain period must likewise be indicated or stated, or when Device Information shall be destroyed be likewise stated.

There are no specific rules on cookie retention periods or retention periods for similar technologies. The DPA IRR, however, provides that retention of personal data shall only be for as long as necessary: (i) for the fulfillment of the declared, specified, and legitimate purpose, or when the processing relevant to the purpose has been terminated; (ii) for the establishment, exercise or defense of legal claims; or (iii) for legitimate business purposes, which must be consistent with standards followed by the applicable industry or approved by the appropriate government agency. Further, personal data shall not be retained in perpetuity in contemplation of a possible future use yet to be determined. (Section 19, DPA IRR).

SHARING YOUR PERSONAL INFORMATION

We may share your Personal Information only with the Company's authorized personnel or, with your consent, with authorized third parties pursuant to a confidentiality/data sharing agreement. We also use Google Analytics to help us understand how our customers use the Site – you can read more about how Google uses your Personal Information here:
