# BOWWOW's TERMS OF SERVICE

COMMISSIONS ARE FOR PERSONAL USE ONLY AND ARE NOT TO BE USED FOR COMMERCIAL PURPOSES.

**PAYMENT METHOD:** CashApp (I no longer do business through Paypal, due to their unreliable service.)

**MEDIUM:** Digital Only. (Does not require Shipping.)

## WHAT TO EXPECT

Work Hours begin around 3 PM and last until 12 AM, Midnight. If you'd like to contact me, please do so around these provided hours. When contacting me, please directly state that you are interested in a Commission within your introduction, or first message. My Available Slots range from 3-4 at a time, each Month. If you'd like a Commission while Slots are either Filled, or Unavailable, you will be put on the Waitlist in my <u>Public Queue</u> and I will reach out to you once a Slot becomes available!

I am a *Fulltime Artist*, therefore I am *Off Work* during the Weekends and Holidays. Meaning, no progress will be made during that time, and I may not reply to messages until the following Weekday.

All Customers must be of, or over, the legal age of 18, and must provide proof (age in bio, ID, etc.) of age. By Commissioning me, all Customers confirm that they are at least 18+ of Age. Customers must also provide an Email to receive any Finished Commissions. Furthermore, I reserve the right to refuse Service to anyone, without means of clarification.

#### **INQUIRING**

Please no "Beating Around the Bush." Please ask clear and direct questions, such as, "Hi! Is Slot 3 still Open?", "Just checking in! Any updates?", "Hi! Mind if I see the progress so far?", "Hello! May I have a WIP?", "Hi! When's your next Opening?, etc.

I Will <u>Not</u> reply to messages such as, "Hey," "Hi," "How are you?", "What's up?", "How's life?", "How've you been?", "Mow?", "\*boops ur nose\*", ":3", "Bark bark!", etc. during Commissions.

If I am busy with other Customers' updates, then I may not reply to your Update Request, <u>until I am available</u>. Meaning, sometimes, you will have to wait your turn, which may or may not take some time, depending on the scale of each Customers' updates. I will try to get back to you as soon as I can, but please, have patience.

I reserve the right to forfeit any Slot to the next Customer, if a reply is not received within 48-72 Hours after inquiry. In the case of Ghosting, you will be Blocked.

Once I have confirmed your Commission, I will send you a Payment Request via <u>CashApp</u>. Please, have your CashTag ready before inquiring. All Payment is due <u>Upfront</u>, upon receipt, in order for any work to begin. Lowering prices is non-negotiable. The Payment Request will be sent from "SnarkysmirkArtwork," as this is my general username across most platforms. Once the Payment has been received, work will begin shortly!

### WHAT YOU MIGHT NEED

During the Discussion of your Commission, I will likely ask for the Size of Commission, Color of Commission, Type of Background, All necessary References, Sfw or Nsfw, as well as for any specific details for the piece (ex. pose, scene, dialogue, props, diapers, pull-ups, undies, desired outfits, etc.), or requests such as "Do Not Publish," and/or Alternative Versions.

Please have your Character(s) <u>fully fleshed out and ready</u> for the Commission ahead.

I only accept Digital Images as References. I apologize if it's of any inconvenience, but I no longer accept Traditional Images (ex. drawings on paper, notebook doodles, etc.), nor loose descriptions, as Reference material. This is due to the fact that obtaining exact colors through this method is quite difficult and often leads to much back-and-forth. Flatcolor images and Reference Sheets are preferred, however links to images, as well as Folders that can be viewed online (via Toyhou.se, Furaffinity, Deviantart, etc.) are also acceptable.

Written descriptions of Characters are <u>Not Accepted</u>, unless in Full Character Sheet format, provided with Hex Codes for exact Color(s). I no longer accept, "I imagined X looked like Z, but with Y hair." I no longer do Artistic Freedom Character Design(s), but I will gladly do Artistic Freedom Outfits for your Character(s).

Written descriptions of Minor Adjustments on behalf of Reference (ex. Provided Character, but with two tails instead of one, etc), and/or pose (ex. Provided Character, but with two tails, waving, etc) are acceptable. Furthermore, descriptions, moodboards, photos, etc. are all acceptable for creating the Commission's Background, Setting, or Scene.

I will <u>Not</u> Accept the Following as Character Reference Material: Real Life Photos, Photos of Celebrities, Photos of Actors, Photos of anything Live Action, etc.

#### THE PROCESS

Turnaround time varies. Depending on my current Queue, Waitlist, Holidays, and Workflow. After ordering, a "Mock-up" sketch will be provided within the next 2-3 days, depending on work flow, to establish a rough idea. During sketching, you may ask for any necessary changes and edits, free of charge. Once I have begun Lining, all changes and additions will be at an additional cost. WIP images will be provided as progress on your Commission is being made. Please don't be afraid to ask for extra WIPs!

You should expect at *least* one WIP Update Image for each stage of Completion (ex. Sketch, Lineart, Coloring and/or Shading). During each stage, your Approval will be required in order to continue. To check your Commission's status, please check my <u>Public Queue</u>. If your Commission has a "Pending Approval," Tab, then your Approval of the WIP Update is Required. Again, I am able to send more WIPs between these stages of approval when requested, but you should expect 2-3 Updates by default, for each stage.

Minor Revisions are free; Full Revisions (ex. change of character or redrawing a pose and/or prop) or Major Additions, often will be charged extra, depending on the amount of changes, and how completed the piece is at the time of the change request. This does not include correcting mistakes (ex. wrong eye color, wrong marking placement, etc.) as that is my fault, and I will gladly fix any mistakes at any time.

All Commissions are exclusively Digital and do NOT require shipping. Once a piece is fully completed and approved, your Commission will be sent directly to you via Email, and uploaded to the respective social media platform which you will be tagged in, unless you have requested for a D.N.P/"Do Not Publish," or for the piece to be uploaded anonymously.

Any work that has been Finished may not be:

- Altered without Permission.
- Reuploaded with the Signature removed, without Permission.
- Resold higher than the Original Price.
- Duplicated without Permission.

## TIP AND REFUND POLICY

Full Refunds are only available before work has started. Only Partial Refunds are available once progress has been made on the Commission. The amount refunded after starting the piece will be equal to that of the Unfinished Progress of the Commission. Once your Commission has been refunded, your Commission will be considered Canceled and cannot be resumed.

Refunds are no longer available once the Commission has been completed.

**Tips may be given at any time!** Tips are not required, but highly appreciated! You may Tip anytime you'd like, whether it be **before**, **during**, **or after the Commission**. **Tips are accepted via <u>CashApp</u>**, <u>USD</u>. If you'd like to send a Tip, you may send your Tip to \$SnarkysmirkArtwork on CashApp.

#### **BOUNDARIES AND LIMITS**

The Maximum for Extra Characters is 5, not including the Main Character. I will no longer draw groups bigger than 6 in total.

All Commissions must be Babyfur, Kidfur, Middlefur, Littlefur, ABDL, DL, or Ageplay related. I will not create any "Off Topic," content. So, if it falls under the ABDL umbrella, you're good to go! Diapers are not required, but preferred.

All Fanart must be ABDL/Ageplay related, and all Characters featured in the Fan Art must be 18+ of age.

All Diapered content may Only have a Mild to Moderate gradient discoloration and/or Mild to Moderate size difference. Diapers/Pull-ups can be Mild to Moderately heavy and/or droopy. Diapers/pull-ups can be mildly leaky, but no malfunctions (heavy leaking/running, blow-outs, ripping, etc). Dry/Wet, Preferred. Mess/Blorting, please ask.

Scenes involving **Bed Wetting, Heavy Messing/Scat, Hyper Mess Staining, Hyper Diapers,** and **"Hard" Drug Use** (such as Whippets, Coke, Pill Popping, etc.) are **Unavailable** unless stated otherwise.

Characters with Child-like bodies (ex. lolis, shotas, etc.) are not allowed. However, most short and/or petite OCs are ok! Please don't be afraid to ask:3

All Characters, regardless of proportions in provided References, will be drawn with adult-bodied proportions. I will not draw Child-like proportions, \*especially\* in

#### Nsfw scenes.

If the Commission involves being in Diapers/Pull-ups \*Publicly\*, the allowed diaper/pull-Up peekage depends on the requested scene and/or setting. All Background Characters must be 18+ of age. I will not draw Public scenes involving offending/"grossing out," nor angering, unconsenting bystanders. However, in the case of scenes taking place in ABDL-centric Universes, this rule may be negotiated.

Referencing poses taken from photographs of real-life children is not permitted. Outfit, Prop, or Furniture references that happen to be featuring a child/teen model are acceptable. However, images that do not include the model, or cropping out the model from the image, are preferred.

Please check out my more in-depth "Will and Won't Draw" list on my <u>Public Queue</u>, if you are still unsure about a particular kink and/or scene, or to see my <u>Personal</u> Favorites. If what you're looking for isn't on the list, <u>please don't be afraid to ask!</u>

Additionally, if you'd like to Commission me for a Kink or Scene that is unrelated to ABDL, please check out my "General" Queue for more information. 18+ Only.

Furthermore, any completed work MAY NOT be: Reuploaded with a Removed Signature, Sold as Merchandise, Resold at a Higher Price, Remade as Nonfungible Tokens, used for A.I. Generation Tools, nor used in any way that violates the provided Terms.

## **BLACKLISTING**

All Blacklisting is done <u>without</u> prior, nor future, notice. All Blacklisted individuals shall be <u>Blocked</u> on the Artist's CashApp, plus Social Medias. All Blacklisted individuals are <u>prohibited</u> from <u>any and all</u> further exchanges from the Artist.

# **CLOSING NOTE**

Any violation of the terms and conditions, provided above, may result in the decline or cancellation of the Commission with either a Partial or Full Refund, as well as being placed on a Blacklist, denied future services, and/or blocked.

If you, the Customer, did not read the above Terms of Services, I will not be held responsible for your own misconception(s). I reserve the right to take action, upon discovery that a breach of the above Terms and Conditions has been made. I retain the rights to the Commissioned Artwork(s).

By contacting me for my services, you, the Customer, confirm that you have read and agreed to all of the provided terms and conditions.
