II. BRIEF CONTEXT/PERSPECTIVE OF THE ACTIVITY

In our school, we have noticed that some students occasionally overlook rules on proper attire and behavior, such as wearing tattered jeans or cropped tops, bringing vapes, or for male students, wearing earrings. These actions, while sometimes unintentional, can affect the school's image and the sense of safety and order we all share. As SSLG officers, we recognized this as an opportunity to take part in promoting discipline and respect among students. We realized that many simply need reminders and guidance to better understand that these rules are not just about appearances—they are meant to keep everyone safe and foster a respectful environment for learning.

This issue exists mainly because not everyone fully understands the purpose behind school policies. Some may see them as restrictions instead of values-based guidelines for proper conduct. As student leaders, we felt the need to respond not with punishment, but with patience and understanding. It made us realize that discipline grows through example and consistent effort. By helping one another follow simple rules, we strengthen our community's sense of responsibility and unity. We discovered that when students are guided with respect, they respond with the same respect in return.

With this in mind, we initiated **Project Gate Watch: Promoting Discipline and Safety at the School Gate**. This daily activity, led by SSLG officers with support from our adviser and the Prefect of Discipline, takes place every morning to remind students of proper conduct before entering school. The project aims to build a safe and orderly environment where discipline begins at the gate and continues throughout the day. The beneficiaries are all students of Mambajao National High School, who will experience a more positive, secure, and respectful school atmosphere—showing that small acts of responsibility can make a big difference in shaping a better community.

- To remind students daily of the school’s policies on attire, behavior, and prohibited items.
- To help maintain peace, order, and safety within the school community.
- To develop a sense of responsibility and leadership among SSLG officers through active participation in discipline enforcement.
