The eGovernments Foundation's core purpose is to foster an ecosystem that supports the collaborative and public development of free and open source software platform. This privacy policy ("Privacy Policy") describes our policies and procedures about the data collection, use, disclosure and sharing, or other processing of your personal information when you use our offering from the azure marketplace, participate in our events, programs, trainings and our other services and offerings.

Information Collection And Use

While you opt to use our platform we collect few information for various purposes to provide and improve our Service to you.

Types of Data Collected

Personal Data

While using our platform, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

Usage Data

Tracking & Cookies Data
