- 4. Staffing The following positions are being requested on behalf of the administration for the 2022-23 school year and beyond. We would like permission to post, advertise, and interview for the vacancies below. We would like to hire for these positions by June 30, 2022.

 - ii. Tried numerous times to hire LPNs and we have been unsuccessful
 - iii. Value Added: will now permit IUP students to travel to East Pike and assist in screenings and other health-related needs/challenges/requirements.

- 5. Synchronous Instruction 2022-23
 - a. Secondary Level we would like to end this option due to lack of use and associated cost/benefits.
 - Would free up 10 more sections at the secondary level that can be used to lower class size, provide remediation, and/or provide time for SAP teams to meet/plan.
 - b. Elementary Level we would like to end this as an option for Kindergarteners and 1st graders starting in the 2022-23 school year.
 - i. In-person learning is best and it appears we are making strides to return to normalcy and cases/rates are dropping at a significant rate.
 - 1. For example, we only have 4 students enrolled in one elementary grade.
 - ii. This would allow us to move one of the synchronous teachers to fill a vacancy in the elementary level
 - iii. We could use ESSR grants for the next year until we see more students come back 100% full-time to in-person learning

At their District's Board meeting on February 28th, CKLA was adopted for their K-5 classrooms.

7. Girls Wrestling

- a. Recently, the PIAA voted unanimously to approve girls wrestling as a PIAA Emerging Sport. This makes girls wrestling the <u>first sport</u> to be named as an Emerging Sport under the PIAA's new Emerging Sport Process that was adopted last fall.
- b. What does this mean for the sport? This designation indicates that girls wrestling is a sport that the PIAA is tracking for potential full sponsorship and demonstrates that girls wrestling has a clear plan and path to sanctioning in the PIAA's eyes.
- c. What does this mean for your school? With girls wrestling growing throughout PA and the PIAA viewing the sport as on track for sanctioning in the future, you can start a girls wrestling team with confidence that it will become a full PIAA-sponsored sport. To start a team, a School Board can vote to approve a girls HS team or this statement can be signed and submitted to SanctionPA at sanctionpa@gmail.com. We currently have teams at 34 PIAA schools and expect many more before next season starts.

Remember, there is no minimum number of girls required to start a team, there are competitions available, and girls can double roster until sanctioning. Also,

girls wrestling rules are the same as the boys', the same facilities and practice times can be used, and the same coaching staff or additional staff are allowed to oversee a girls program.
