



# UNKNOWN [?] Trading Company Budget 2024-2025

Making consolidated appropriations for the fiscal year ending September 1st, 2025.

Be it enacted by the Imperial Assembly of the UNKNOWN [?] Trading Company in West-Ministry assembled.

## TITLE I

No alterations or deviations to the consolidated appropriations will be accepted by the Clan for the entire fiscal year 2024-2025. All spending outside of the designated scope of four-thousand eight-hundred(4,800) United States Dollars(USD) as it was passed by the Assembly shall not be honored by the Bank of the Unknown [?] Clan.

## TITLE II

### **DIVISION A**

#### **RENDERING SERVICES TO THE UNKNOWN [?] TRADING COMPANY.**

For necessary expenses of rendering of services, \$1200, shall be available for miscellaneous employment to offices of the UNKNOWN [?] Trading Company and for general administration, security, repairs and alterations, and other miscellaneous supplies and expenses not otherwise provided for and necessary for the practical and efficient work of the UNKNOWN [?] Trading Company as determined by the Directory and or the office incumbent designated with the role of Paymaster.

### **DIVISION B**

#### **TECHNOLOGY AND INFRASTRUCTURE TO THE UNKNOWN [?] TRADING COMPANY.**

For necessary expenses of rendering of services, \$1200, shall be available for miscellaneous employment to Information Technology and other Advanced Communication Assets and for general administration, security, repairs and alterations, and other miscellaneous supplies and expenses not otherwise provided for and necessary for the practical and efficient work of the UNKNOWN [?] Trading Company as determined by the Directory and or the office incumbent designated with the role of Paymaster.

**DIVISION C  
ADMINISTRATION TO THE UNKNOWN [?] TRADING COMPANY.**

For necessary expenses of rendering of services, \$2000, shall be available for disposable currency as determined by the Directory for the benefit of the UNKNOWN [?] Trading Company.

**DIVISION D  
RECRUITMENT & TRAINING TO THE UNKNOWN [?] TRADING COMPANY.**

For necessary expenses of recruitment and training, \$200, shall be available for Company Citizens, Company Members and Directorates responsible therein for bringing in recruits and for their training to the UNKNOWN [?] Trading Company as determined via criteria established by the Directory and or the office incumbent designated with the role of Paymaster.

**DIVISION E  
WINTERHILFSWERK OF THE UNKNOWN [?] TRADING COMPANY.**

For necessary expenses of the Winterhilfswerk Charity Program, \$200, shall be available for Company Citizens, Company Members and Directorates eligible for charity and aid as determined via criteria established by the Directory and or the office incumbent designated with the role of Paymaster.

**TITLE III**

**DIVISION A  
UNALLOCATED FUNDS AND THEIR USE.**

Funds not allocated at the end of the fiscal year are to be reserved solely for the Winterhilfswerk Program.

**DIVISION B  
DEBT**

The Bank of the Unknown [?] Clan shall not bear any burden for debt incurred through spending beyond the consolidated allocation of funds.

**DIVISION C  
TAX AND TRANSFER FEES**

Tax and Transfer fees and other miscellaneous premiums provided by the payment platforms are not borne by the Clan and are the responsibility of the payees; whereas if the tax and transfer fees far exceeds the agreed upon payment, the Clan maintains its right to refuse and withhold payment.

## TITLE IV

In the event of the outbreak of a major war, in particular, with the direct involvement of the People's Republic of China, the UNKNOWN [?] Trading Company may choose to suspend operations and confiscate all pay for the purpose of assisting all Company Members and Citizens affected by relevant belligerents.
