

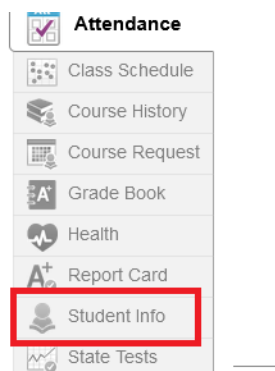
Walkthrough

Step 1: Start by logging into your ParentVUE account by going to the link [ParentVUE](#) and clicking “I am a Parent” or go to www.juhsd.net click on the “Parents” tab at the top and then the “Parentvue” link on the left.

Step 2: After logging in, please click on the student information tab on the left side of your screen.



Step 3: Once the student information page is loaded scroll to the bottom of the page and review the memo regarding the COVID-19 return to school survey questions.

Please carefully read and review important information from the district below. After you are done please click on the "Edit Information" button at the top of the screen to select your response for this survey.

Return to Campus Selection Introduction

The purpose of this form is for parents to select the type of instruction their student will receive for the remainder of this semester. We are planning for a gradual return to in-person instruction, and need to know how many students are planning to return to campus.

You have a choice of hybrid or distance learning. All students, regardless of whether they are in hybrid or distance learning, will have the opportunity to participate in extracurricular activities in person with parental permission.

Strict safety protocols will be in place, including social distancing, masks at all times except when eating or drinking, and daily health screenings. Students will not congregate, and will be highly encouraged to be tested for COVID-19 frequently, regardless of their vaccination status.

Instructional Model choice

Option 1: Hybrid Instruction (2 days in school and 2 days in Distance Learning)

Students will attend school in person twice a week and participate in the same classes virtually twice a week. Students, even while at school, will still be logging into Zoom to participate in their classes. Teachers will instruct in-person and distance learning students simultaneously.

Option 2: Remain in Distance Learning (4 days in Distance Learning)

Students will continue to engage in fully virtual learning four days a week.

Please note, regardless of which option you choose, you will have another opportunity to determine which instructional model your child participates in, and this will take place approximately four weeks after hybrid instruction begins.

Wednesdays are asynchronous days where students can either attend teacher office hours, small group interventions, or participate in asynchronous learning.

Option 1: I want my child to move to Hybrid Instruction

I understand that in-person learning will only take place for two days per week. I understand that by returning to in-person school, my child will be required to follow all reopening procedures/protocols including wearing a mask, 6 foot distancing, washing hands often, daily health screenings, and following 10-day quarantine requirements due to travel. I understand that students will not be allowed to congregate. I understand that my child will be randomly tested for COVID-19. I understand that my student will have one opportunity approximately four weeks after Hybrid Instruction begins to change their status to return to Distance Learning.

Option 2: I want my child to stay with the current virtual learning model

I understand this is a full day of virtual instruction, with similar minutes to the current Distance Learning model. I understand that my student will have one opportunity approximately four weeks after Hybrid Instruction begins to change their status to Hybrid Learning.

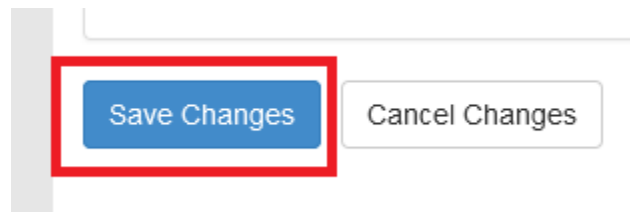
Student and Parent Agreement

5. Being randomly tested for COVID-19.

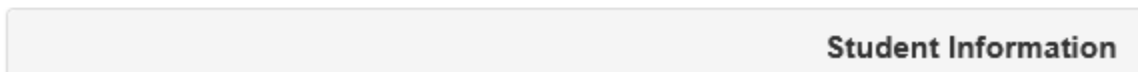
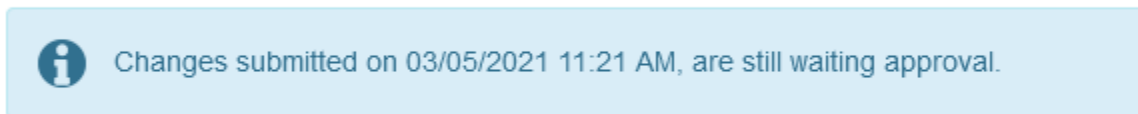
