It has come to my attention that an Ongezellig (surprise surprise) server named Roosland has been **refusing to take action to safeguard members from potentially predatory behaviour** out of bias to protect active members from scrutiny.

These biases have culminated in a larger effort spearheaded by server moderators and the owner themselves to conceal said behaviour. I will be speaking of numerous instances where this issue has made itself known and **Roosland has remained adamant in complete inaction**. I will provide proof of their refusal to act, and of the recurring issue.

Distribution of explicit content to minors, an issue repeating itself over a span of 4 months. Although the server is aware of this, action has not been taken even upon direct request to the owner.

The refusal to take action and the clear biases presented by the owner and moderators.

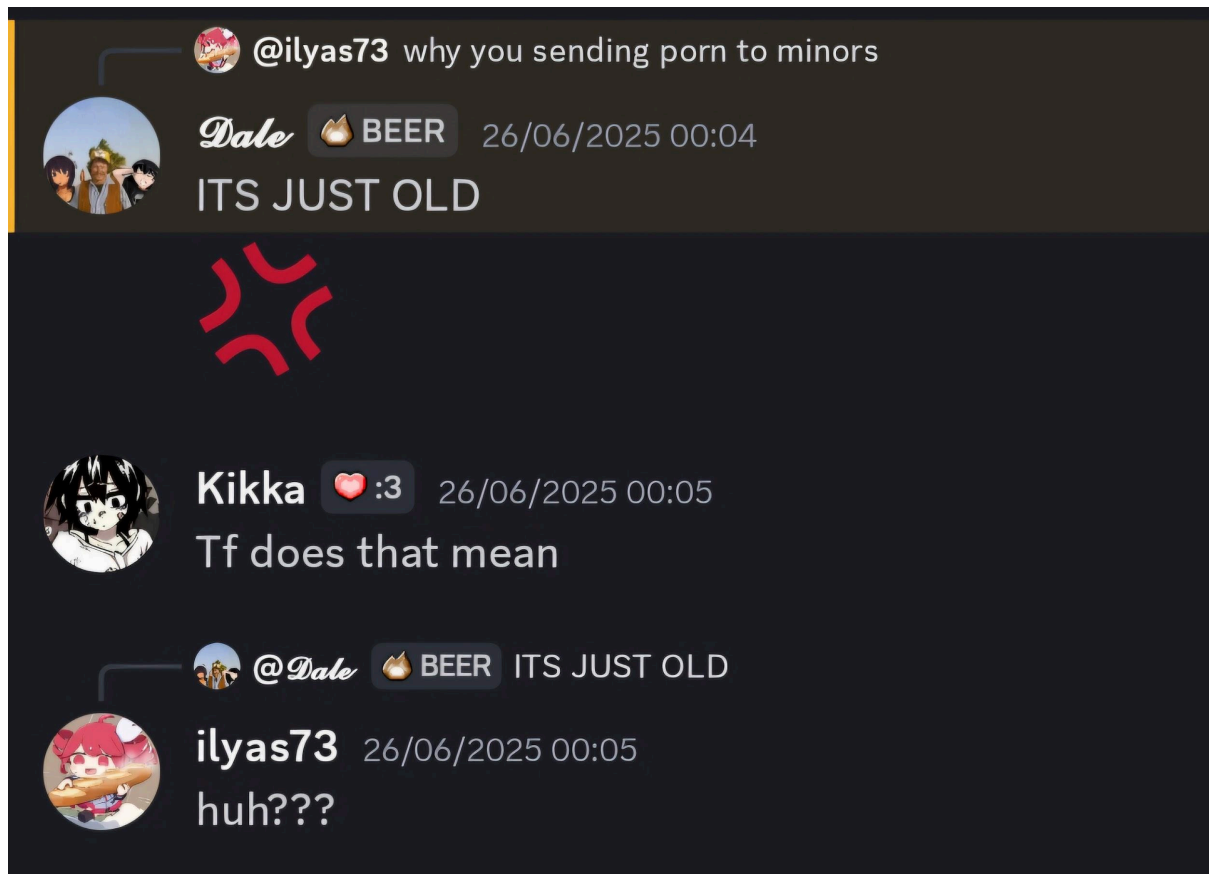
Censorship of evidence and information regarding the situation in Roosland, a direct byproduct of bias toward the member who has been actively in violation of the law.

Dale is a mod for both Roosland and Byrdland and has been consistently distributing NSFW content to minors over a span of 4 months. This was discovered shortly after I confronted Dale about the content which he was giving to two other Roosland members. Both were underage.

In the screenshots below, Dale dismisses the importance and undermines the gravity of his actions, trying to use the span of time in which he did it to mount a defense in his favour.

Context: Dale was questioned about the reason he sent pornographic material to minors.

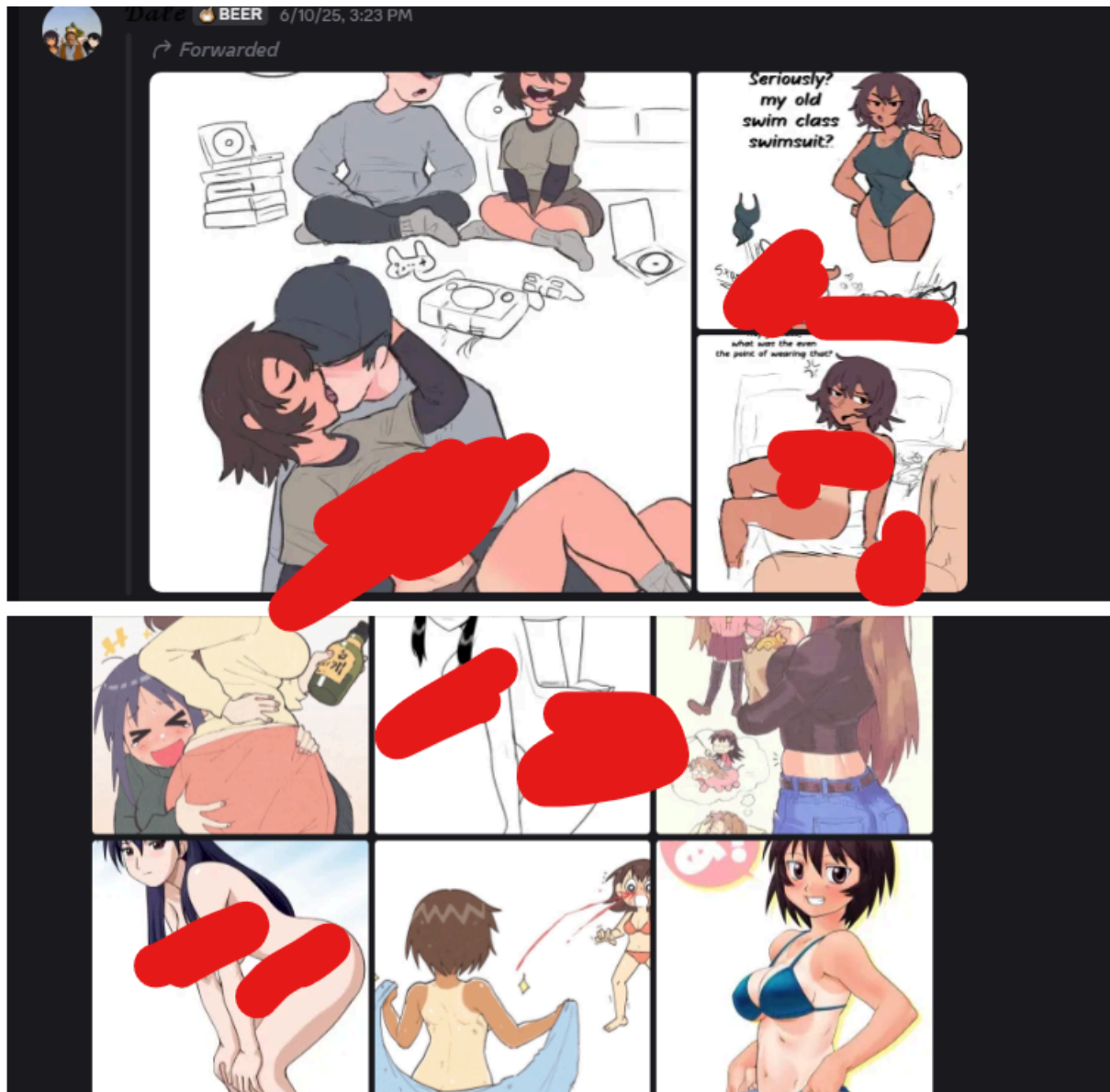

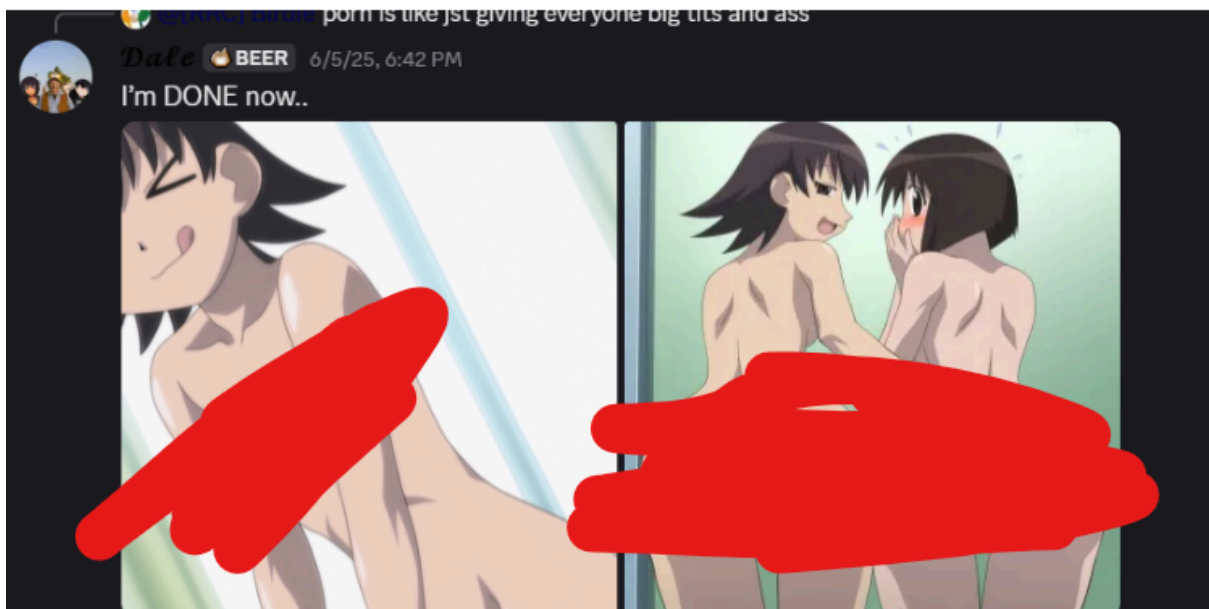
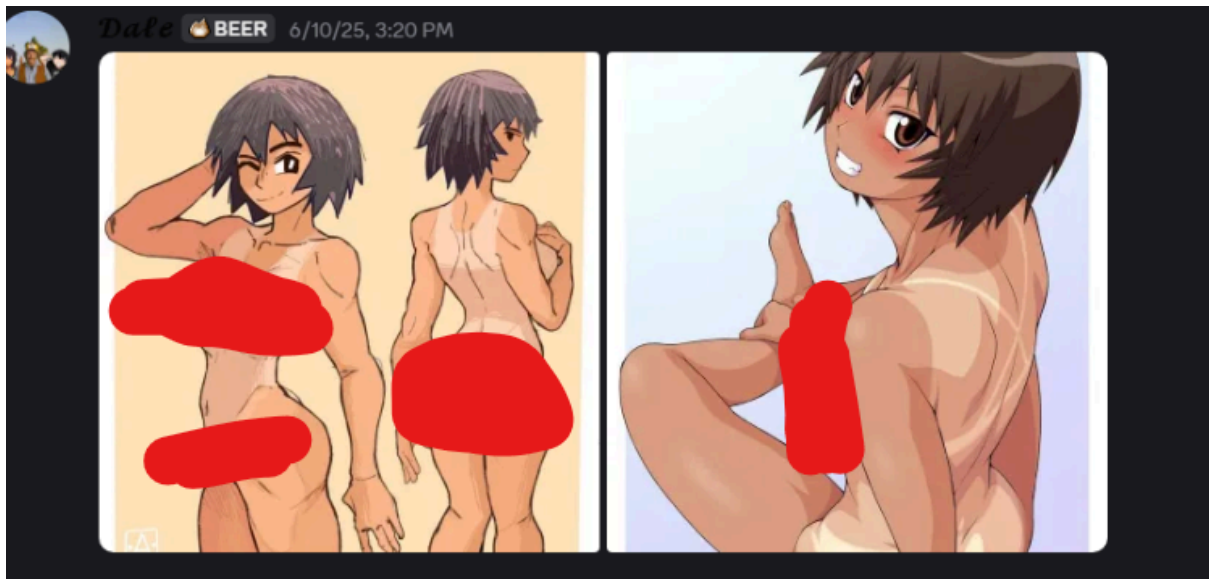

LEGAL STANDING

Texas Civil Practice and Remedies Code

Chapter 129B (H.B. 1181, effective Sept 1, 2023)

Defines “sexual material harmful to minors” and “minor”

Texas Penal Code § 43.24

The sale, distribution, or display of Harmful Material to a Minor

Makes it a **Class A misdemeanor** to knowingly sell, distribute, or exhibit harmful material to anyone known to be a minor

If a minor is used in the content violating this law, the severity **elevates to a State Jail Felony.**

Defines “harmful material” as material that:

1. Appeals to prurient interest of minors
2. Is patently offensive by community standards
3. Lacks serious literary, artistic, political, or scientific value

Texas Penal Code § 43.23 & § 43.26 Child Pornography and Obscenity Laws

Under § 43.23 the wholesale promotion or possession (with intent to promote) of obscene material is entirely prohibited, elevating the severity to that of a felony if it **depicts minors in sexual acts.**

Under § 43.26 the possession or promotion of child pornography (sexual conduct involving a minor) is entirely prohibited with **punishments ranging from third-degree up to life imprisonment** depending on severity.

Under CPRC 129B Online distribution of porn harmful to minors equates to **18 Civil fines daily and totaling up to \$250k.**

Under PC § 43.24 Selling and or distributing harmful material to minors equates to a Class A misdemeanor and if involving minors within the aforementioned explicit content the severity elevates to that of a State jail felony.

Dale is in clear violation of the law.

Has distributed pornographic content to minors (see CPRC-129B)

Has been in possession of pornography depicting children, content imitating the sexual abuse of minors

(see Texas Penal Code § 43.26)

Has given minors access to harmful and/or obscene content

(see Texas Penal Code § 43.24)

SERVER BACKING

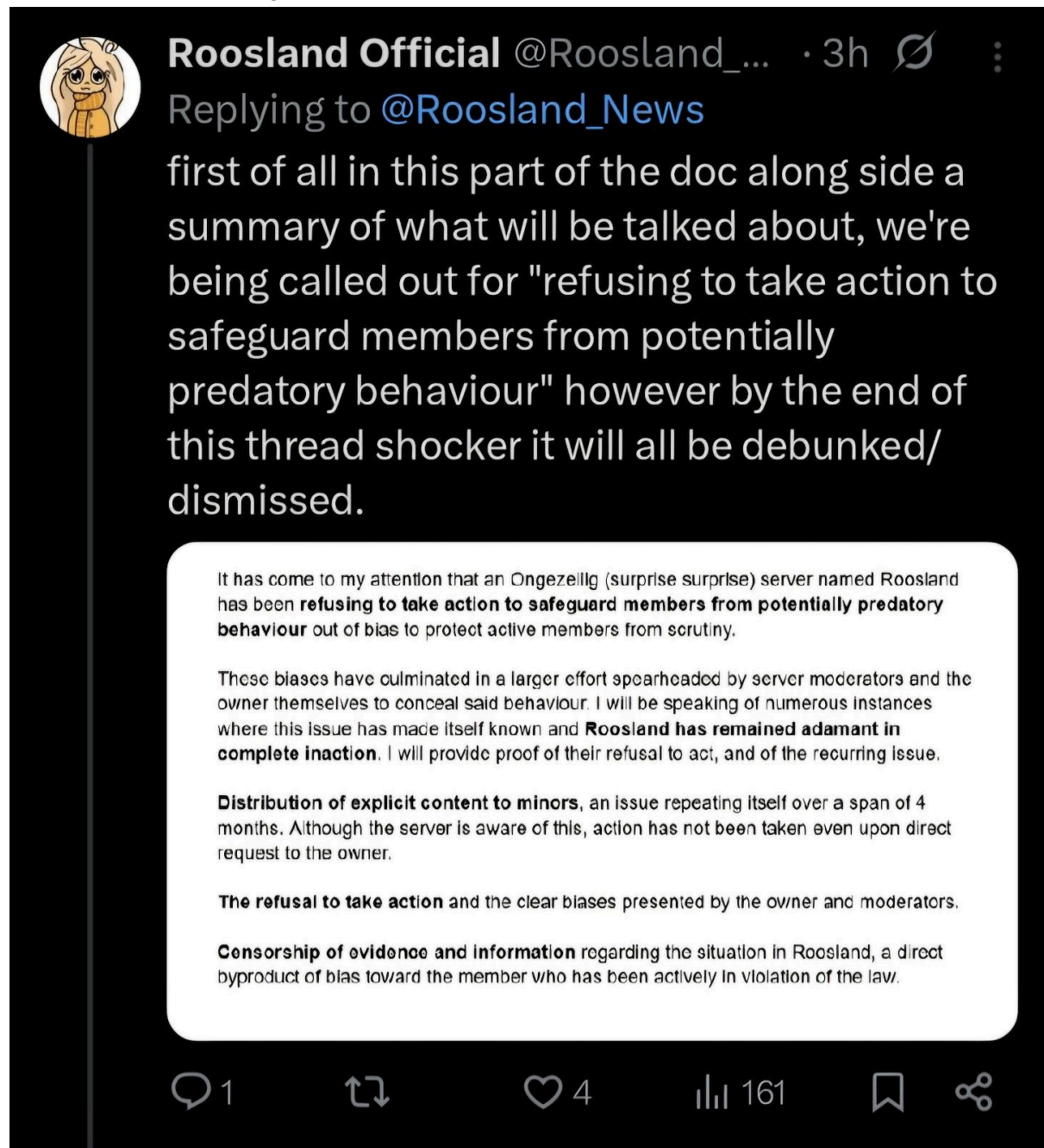

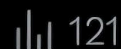

The law being mentioned here is the Romeo and Juliet Law. **The Romeo and Juliet Law protects sexual consent between two minors within a three year age gap under Texas Penal Code §22.011(e).**

However, entirely contrary to the skewed and potentially dangerous narrative surrounding the law being proposed by Roosland, The Romeo and Juliet Law **does not protect virtual pornographic content involving minors within the aforementioned age gap.**

Violations of Texas Penal Code § 43.23 and § 43.26 are **NOT PROTECTED UNDER THE ROMEO AND JULIET LAW.**

Dale is still not under the protection of The Romeo and Juliet Law whilst distributing virtual child pornography.

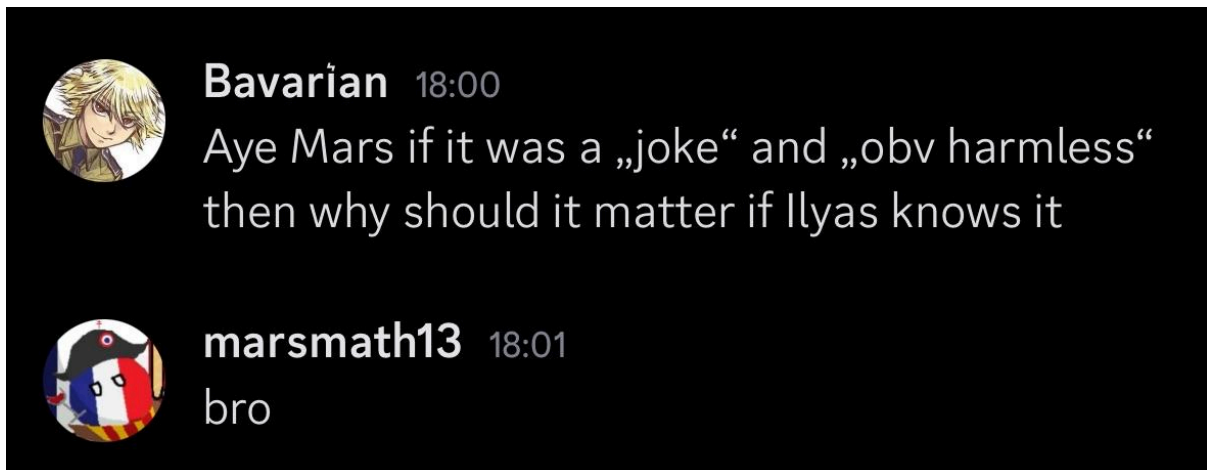
NOT FUN FACT

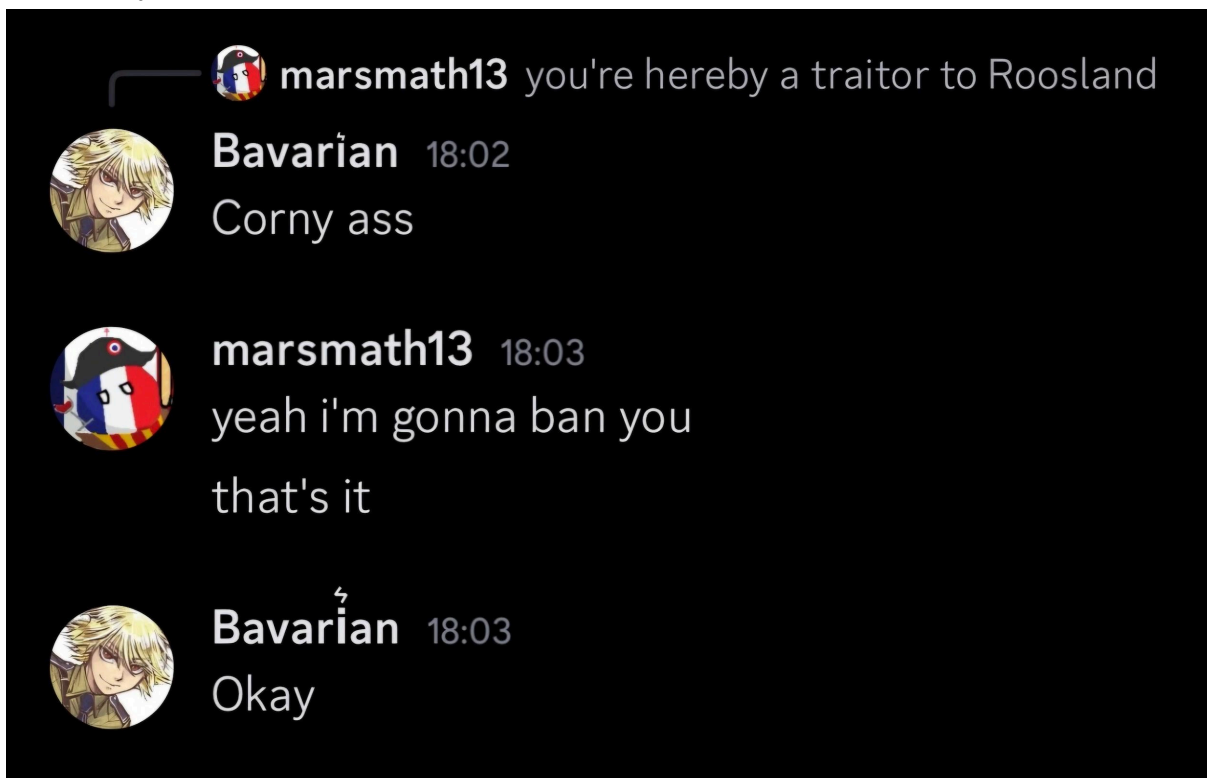
This means that **78% of messages sent by Xalae involving children are associated with child porn.**

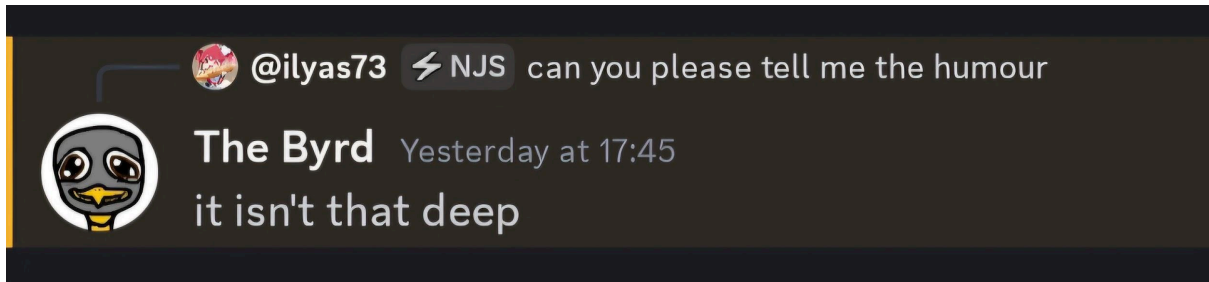

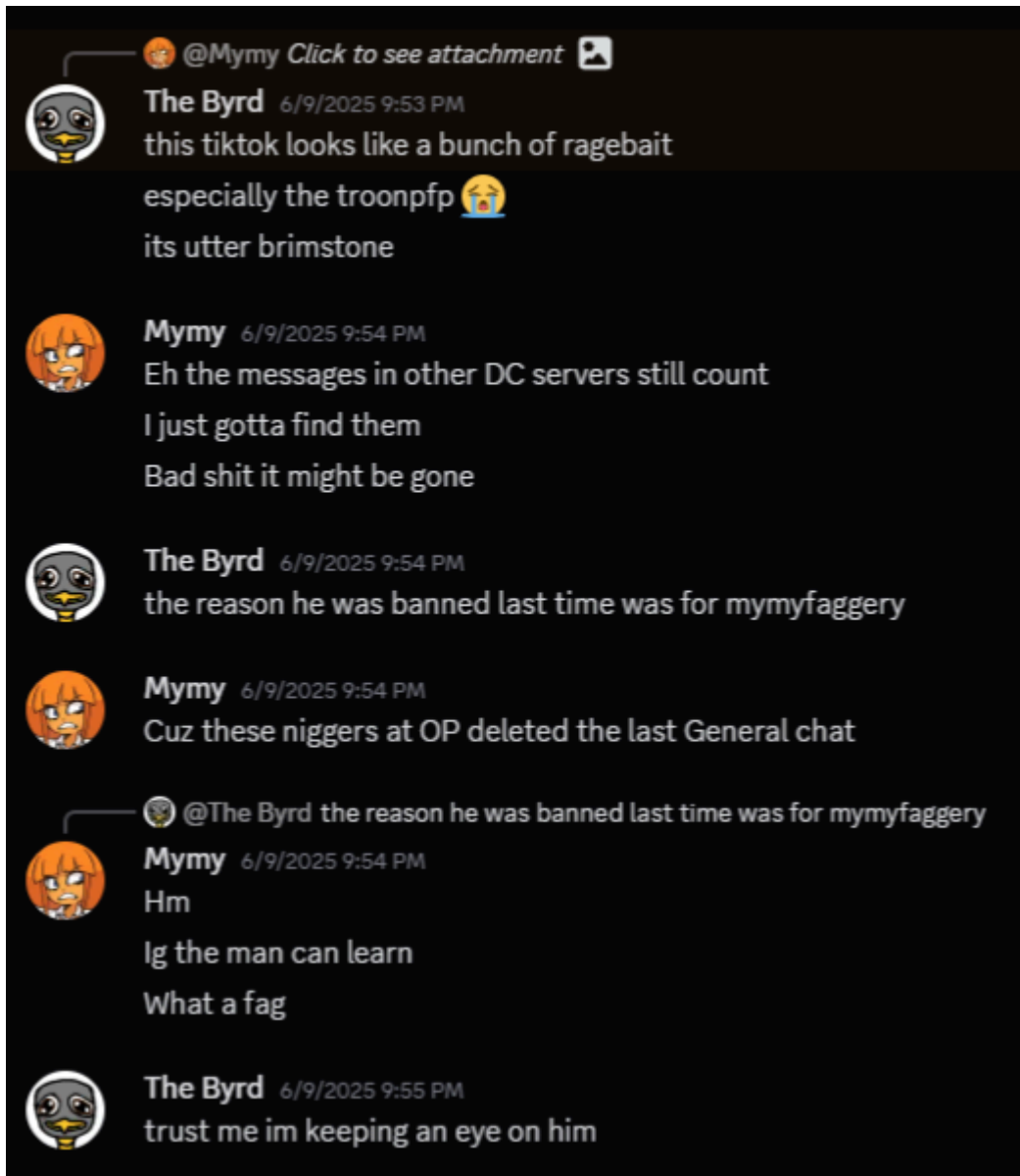
